SUBJECT: DEP. PM SHEARER'S APRIL 8 STATEMENT
ON VOGEL TESTIMONY

THE TEXT OF DEP. PRIME MINISTER/FOREIGN MINISTER SHEARER'S APR 8 STATEMENT ON THE APR 5 CONGRESSIONAL TESTIMONY BY CONVICTED NARCOTICS TRAFFICKER MICHAEL VOGEL FOLLOWS BELOW. BEGIN TEXT:

A. A FEW DAYS AGO THE JAMAICAN AMBASSADOR TO THE UNITED STATES BROUGHT TO OUR ATTENTION THE FACT THAT, ON TUESDAY, 5TH APRIL, DURING THE COURSE OF HEARINGS BEING CONDUCTED BY THE SENATE FOREIGN RELATIONS SUBCOMMITTEE ON TERRORISM, NARCOTICS AND INTERNATIONAL COMMUNICATIONS, A CONVICTED DRUG TRAFFICKER INFORMED THE SUBCOMMITTEE OF HIS OWN CONNECTIONS WITH DRUG DEALINGS IN JAMAICA AND WENT ON TO MAKE STATEMENTS CLEARLY INTENDED TO IMPLICATE THE PRIME MINISTER OF JAMAICA AND THE COMMISSIONER OF POLICE AND TO TARNISH THE INTERNATIONAL IMAGE OF JAMAICA. ALL OF THESE GRAVE ALLEGATIONS ARE TOTALLY FALSE, AND THE GOVERNMENT OF JAMAICA IS ALARMED AND DEEPLY CONCERNED THAT THE PANEL OF SENATORS DID NOT SEEK TO PROBE FURTHER INTO THESE ALLEGATIONS.

B. THE AMERICAN AMBASSADOR IN KINGSTON WAS CALLED IN AND INFORMED THAT THE GOVERNMENT OF JAMAICA TAKES THE STRONGEST POSSIBLE OBJECTION IN THIS MATTER BECAUSE:

--THE TESTIMONY OF THIS CONVICTED FELON, WHICH WAS PUBLICLY GIVEN, WAS ALLOWED TO STAND WITHOUT ANY ATTEMPT TO PROBE FURTHER INTO THE ALLEGATIONS TO ESTABLISH IF THESE STATEMENTS WERE ACCURATE OR WHETHER THE INFORMANT WAS COMMITTING PERJURY.
--THE USIA ADVISORY ON THE MATTER, WHICH WAS CLEARLY DESIGNATED FOR FOREIGN SERVICE CIRCULATION, CONTAINED INACCURACIES BUT WAS NEVERTHELESS DELIBERATELY RELEASED TO THE MEDIA IN KINGSTON.

C. IN VIEW OF THE GRAVE IMPLICATIONS FOR THE ENTIRE COUNTRY AND FOR THE INDIVIDUALS MENTIONED IN THE TESTIMONY, THE JAMAICAN AMBASSADOR IN WASHINGTON YESTERDAY LODGED A FORMAL PROTEST IN

WASHINGTON WITH THE STATE DEPARTMENT.

D. THIS MORNING, MR. JOHN C. WHITEHEAD, ACTING SECRETARY OF STATE, IN A TELEPHONE CONVERSATION, INFORMED ME THAT THE STATE DEPARTMENT HAD ISSUED A STATEMENT IN WASHINGTON, IN WHICH HE SAID THAT THE TESTIMONY OF MICHAEL VOGEL, THE CONVICTED DRUG DEALER, ABOUT THE PRIME MINISTER AND UNNAMED JAMAICAN OFFICIALS, IS COMPLETELY UNSUBSTANTIATED AND THAT THESE ALLEGATIONS AGAINST THE PRIME MINISTER WERE BASED ON AN UNIDENTIFIED SOURCE IN THE CAYMAN ISLANDS AND ARE AT BEST COMPLETE HEARSAY.

ACTION IS PROCEEDING THROUGH THE APPROPRIATE CHANNELS WITH A VIEW TO TAKING STILL FURTHER STEPS, AS SPEEDILY AS POSSIBLE, TO THE FULL SATISFACTION OF JAMAICA AND OFFICIALS MENTIONED IN THE BLATANTLY FALSE TESTIMONY.

PRIME MINISTER SEAGA WILL BE ADDRESSING THE NATION ON THIS MATTER TONIGHT.
