SOLIDARITY WITH THE PEOPLE IN EL SALVADOR" (CISPES) CHAPTER AT THE
OLD DOMINION UNIVERSITY (ODU), NORFOLK, VA. CISPES IS AN ORGANIZA-
TION IN OPPOSITION TO U.S. POLICY IN EL SALVADOR. THE ODU CHAPTER
HAS REPORTEDLY FOUNDED IN LATE 1982 OR EARLY 1983. IT IS A
UNIVERSITY RECOGNIZED STUDENT ACTIVITY; HOWEVER, UNIVERSITY POLICY
DICTATES THAT POLITICAL/RELIGIOUS GROUPS ARE NOT ENTITLED TO RECEIVE
UNIVERSITY FUNDING. (SOURCE ESTIMATES THAT CHAPTER MEETINGS
NORMALLY DRAW FEWER THAN TEN ATTENDEES.)
