 STUDENT AND SOLIDARITY GROUPS ALLEGEDLY PROVIDING ECONOMIC AID AND
 MATERIAL SUPPORT (EQUIPMENT AND SUPPLIES) TO STUDENT ASSOCIATIONS
 CONTROLLED BY INSURGENT ORGANIZATIONS AT THE NATIONAL UNIVERSITY OF
 EL SA VLADOR (UES).~~SECRET NOFORN~~

TEXT 1. (S/NF) THIS IS THE SECOND IN A SERIES OF FOUR REPORTS DERIVED FROM THE INTERROGATION OF RUFINO ANTONIO ((QUEZADA)) SANCHEZ, PSEUDONYM (P) CHILO AND (P) TONO, WHO WAS CAPTURED IN SAN SALVADOR, ES, ON 20 MAR 86 AND WAS ALLEGEDLY A MEMBER OF THE FUERZAS POPULARES DE LIBERACION (FPL - POPULAR FORCES OF LIBERATION).

2. (U) THE FOLLOWING INFORMATION IS AN EXTRACT OF SOURCE DOCUMENT AND IS CLASSIFIED SECRET IN ITS ENTIRETY.

QUEZADA AND RODOLFO ((ROSALES)), (P) DIMAS, VISITED THE US FROM 8 OCT TO 26 NOV 85. THE PURPOSE OF THIS VISIT WAS TO CREATE RAPPORT AND MEET WITH SEVERAL USSA (UNITED STATES STUDENT ASSOCIATIONS), SOLIDARITY GROUPS, AND OBTAIN FINANCIAL SUPPORT TO EXPAND EVEN FURTHER THE STRUGGLE IN ES THROUGH THEIR SUPPORT TO HIS ORGANIZATION. (RO COMMENT; POSSIBLY REFERS TO AGEUS (ASOCIACION GENERAL DE SALVADORN UNIVERSITY STUDENTS.) THE TRIP WAS AUTHROIZED BY THE SALVADORAN GOVERNMENT. QUEZADA AND (P) DIMAS USED THEIR TRUE NAMES AND WERE GRANTED VISAS BY THE AMERICAN COUNSUL, MR. ROBERT J. ((CHAEVEZ))> THEY ALLEGEDLY DEPARTED SAN SALVADOR EN ROUTE TO HONDURAS, BELIZE, AND FINALLY HOUSTON. IN HOUSTON, THEY WERE MET BY A USSA MEMBER NAMED "HELEN" (LNU), WHO DIRECTED THEM TO CONTINENTAL AIRLINES TO BOARD A PLANE FOR WASHINGTON,DC. QUEZADA STATED THAT THE PRESIDENT AND VICE PRESIDENT OF USSA, "TOM" (LNU) AND "CECLILIA" (LNU), BOTH US CITIZENS, HAD ALREADY BEEN INFORMED OF THEIR ARRIVAL AND VISIT AND WERE EXPECTING THEM WHEN THEY ARRIVED WASHINGTON,DC.

QUEZADA DID NOT KNOW THE ADDRESS OF THE USSA OFFICE IN WASHINGTON, DC. THEY MET SOME OF THE 12 MEMBERS OF THE BOARD OF DIRECTORS OF THE USSA, OF WHICH ROBIN ((BRAVERMAN)), QUEZADA'S WIFE IS THE SECRETARY FOR INTERNATIONAL AFFAIRS FOR THE WEST COAST. (RO COMMENT: QUEZADA DID NOT MENTION THE NAMES OF THE OTHER MEMBERS OF THE USSA.)

DURING THEIR 42-DAY STAY IN THE US, THEY TOURED THE FOLLOWING UNIVERSITIES AND RECEIVED 1,00 (US) DOLLARS AND FOUR MICROSCOPES; THE MICROSCOPES WERE ALLEGEDLY DONATED TO THE SCHOOL OF SCIENCE AND HUMANITIES OF THE UES.

- COMITE PRO-AYUDA A EL SALVADOR (PRO-AID COMMITTEE FOR ES) - LOCATED IN WASHINGTON, DC. IS HEADED BY ELIZABETH ((BRENFIR)), A US CITIZEN. THIS COMMITTEE MAINTAINS CLOSE LINKS WITH THE FDR (FRENTE DEMOCRATICO REVOLUCIONARIO - REVOLUTIONARY DEMOCRATIC FRONT) AND CONTRIBUTES 3,000 (US) DOLLARS A MONTH.

- COMITE EL SALVADOR (EL SALVADOR COMMITTEE) - LOCATED IN SAN FRANCISCO, CALIFORNIA, CONTRIBUTES 3,000 (US) DOLLARS A MONTH.
