#### LEGISLATIVE PROPOSALS

101/1 - 1:

### Fiscal Year 1990 Intelligence Authorization Act

The Director of Central Intelligence will submit to the Office of Management and Budget for clearance a proposed Fiscal Year 1990 Intelligence Authorization Act to be transmitted to the Congress.

101/1 - 2:

## Protection of Intelligence Information

The Director of Central Intelligence may propose legislation to provide criminal penalties for the unauthorized disclosure of classified information by Federal employees or others having authorized access to classified information. He may also support this proposal as contained in other legislation.

# Relief From Section 3504 Motions.

The Director of Central Intelligence may propose or support legislation seeking relief from frivolous or burdensome motions filed under the provisions of 18 U.S.C. §3504 (litigation concerning sources of evidence).

### \*DIA Foreign Language Proficiency Incentive Pay

At the request of the Department of Defense, the Director of Central Intelligence may propose or support legislation to authorize the Defense Intelligence Agency to provide incentive pay to civilian employees for foreign language proficiency.

#### DIA Death Gratuity

If not acted upon favorably by the 100th Congress, the Director of Central Intelligence, at the request of the Department of Defense, may propose or support legislation authorizing dependents of DIA personnel killed in the line of duty abroad to receive the general DoD death gratuity.

### \*DIA Overseas Personnel Benefits Comparability

At the request of the Department of Defense, the Director of Central Intelligence may propose or support legislation to give the Secretary of Defense discretionary authority to ensure that DIA personnel serving overseas receive benefits similar to those enjoyed by members of the Foreign Service.

# \*DoD Intelligence Expenditure Authority

At the request of the Department of Defense, the Director of Central

Intelligence may propose or support legislation to give the Secretary of Defense discretionary authority to expend funds as he deems necessary and appropriate to ensure the collection of necessary foreign intelligence is accomplished.

\*Defense Intelligence College Gift Acceptance Authority.

At the request of the Department of Defense, the Director of Central Intelligence may propose or support legislation to give the Defense Intelligence College (DIC) the authority to accept gifts to be used by and for the DIC.

At the request of the Department of Defense, the Director of Central Intelligence may propose or support legislation as necessary to authorize funds and personnel to be appropriated within the General Defense Intelligence Program for use by the Coast Guard Intelligence.

\*DIA Printing Authority

At the request of the Department of Defense, the Director of Central Intelligence may propose or support legislation to enact into permanent law a provision in the FY '88 continuing resolution exempting DIA from the requirement that certain printing be carried out by the Government Printing Office.

Tax Exemption for Allowances
Paid to Certain NSA and DIA
Employees

If it does not otherwise become law during the 100th Congress, the Director may include in the proposed Fiscal Year 1989 Intelligence Authorization bill to be transmitted to Congress an amendment to the Internal Revenue Code to exempt from taxation allowances paid to certain NSA and DIA employees.

\*Exclusion of DIA Director and Deputy Director From Flag Rank Ceiling

At the request of the Department of Defense, the Director of Central Intelligence may propose or support legislation to exclude the positions of Director and Deputy Director of the Defense Intelligence Agency from being counted
