1. Reference (a) announced the approval for the OP-092 charter forwarded by reference (b), and will be incorporated into a forthcoming revision of reference (c). This change is effective on 15 July 1988.

b. OP-092R (009R) is now OP-920 RESOURCE MANAGEMENT DIVISION.

c. OP-092P (009P) is now OP-921 INTELLIGENCE AND CRYPTOLOGIC PLANS, POLICY, AND REQUIREMENTS DIVISION.

d. OP-092Y (009Y) is now OP-922 INTELLIGENCE ANALYSIS DIVISION.

e. OP-092G (009G) is now OP-923 OPERATIONAL SUPPORT DIVISION.


f. OP-092V (009V) is now OP-924 RESEARCH & DEVELOPMENT REQUIREMENTS DIVISION.

g. OP-092I (009I) is now OP-092H ASSISTANT FOR CURRENT INTELLIGENCE.

h. OP-092W (009W) is now OP-092R ASSISTANT FOR RESERVE MATTERS.

i. The OP-009SSO, previously not designated as an OP-092 code, is now OP-092Z, ASSISTANT FOR SPECIAL SECURITY MATTERS.

4. Administratively, within the immediate office of the Director, the Administrative Assistant (previously OP-092D) is now OP-092AA, and the OP-092 Secretariat (previously OP-092DA) is now OP-092S.

DIRECTOR OF NAVAL INTELLIGENCE
OP-092

Mission: To implement CNO responsibilities for intelligence, cryptology (less signals security), special security, and counterintelligence; to serve as the principal staff advisor to SECNAV and CNO in related plans, programming, and policy matters; to represent the Department of the Navy on the National Foreign Intelligence Board, the National Foreign Intelligence Council, and with other agencies in intelligence matters; and to advise and assist Navy Department officials in matters of protocol and liaison with foreign officials.

Functions:

1. Provides intelligence staff support to SECNAV, UNSECNAV, CNO, VCNO, and OPNAV Principal Officials.
2. Serves as the OPNAV CAO for COMNAVINTCOM and COMNAVSECGRU.
3. Formulates policy and provides oversight with regard to counterintelligence (including anti-terrorist intelligence), cryptology (less signals security), and special security.
4. Formulates policy for SCI personnel and information security programs, including protection of SCI, its disclosures to foreign governments, and its control and dissemination within the DON.
5. Participates in the formulation, coordination, and evaluation of national, joint, and naval intelligence estimates.
6. Provides the principal point of contact and advocacy within the Navy in matters pertaining to intelligence requirements, collection, production, and dissemination; advises SECNAV and CNO concerning intelligence equipment, doctrine, and techniques.
7. Directs and coordinates surface, submarine, air and space warfare intelligence matters and collaborates in the conduct of related programs with the OPNAV staff.
8. Ensures Navy intelligence and cryptologic systems are compatible with and, as required, integrated into naval C² architecture.
9. Validates requirements for RDT&E of systems, equipment, and techniques relating to OP-092-sponsored programs, except for those related to C² information flow and tactical support, which are the validation responsibility of OP-094.
10. Sponsors all validated intelligence and cryptologic requirements, including those for which OP-094 is responsible, and coordinates and collaborates with OP-098 in ensuring their satisfaction.

11. Coordinates the development of programs of mutual interest with other Navy Department and DoD offices, as well as U.S. and allied intelligence agencies.
12. Sponsors the Navy portions of the General Defense Intelligence Program, the Consolidated Cryptologic Program, the TCP, and Program VIII cryptologic training resources, and those intelligence-related programs designated by the CNO. Ensures that the programs under OP-092 cognizance receive proper visibility and consideration at all levels of program development and review.
13. Provides principal point of contact for liaison with foreign officials accredited to the DON and advises and assists on matters relating to protocol and official foreign visitors.
14. Represents the DON in the deliberations and activities of the National Foreign Intelligence Board, and National Foreign Intelligence Council; and participates, as appropriate, in other interdepartmental, DoD, and joint service committees.
15. Determines the effectiveness and responsiveness of OPNAV (OP-092)-sponsored programs and special activities to meet current, contingency and mobilization requirements of the Navy and collaborates on actions to correct deficiencies.
16. Collaborates with OP-01 in establishing training, career development, and maintenance of readiness programs relating to the programs sponsored by OP-092.
17. Acts as the primary point of contact with OSD, DoD and U.S. intelligence community agencies, and other foreign and domestic agencies, as appropriate, on intelligence, cryptologic and security matters. Serves as the single point of contact within the Navy for coordinating the forwarding of Navy intelligence and cryptologic requirements and for maintaining liaison to ensure their satisfaction.
18. Acts as the focal point for all interaction between the DON and other departments and agencies of the U.S. government for matters involving sensitive support; accomplishes necessary coordination, obtains proper approvals, and tasks appropriate organizations to provide support.
19. Acts as the Senior Intelligence Officer of the Department of the Navy.

DEPUTY DIRECTOR OF NAVAL INTELLIGENCE
OP-092B

Mission: To implement OP-092 responsibilities with regard to intelligence.

Functions:

1. Acts as principal advisor for intelligence collection and production.
2. Acts for OP-092 to provide intelligence staff support to the SECNAV/UNSECNAV, CNO, VCNO, and OPNAV Principal Officials.
3. Participates for OP-092 in formulating, coordinating, and evaluating national, joint and naval intelligence estimates.
4. Coordinates programs of mutual interest with DON and DOD offices and other intelligence agencies.
5. Acts as OP-092's alternate before the Congress, National Security Council, the Presidential boards and on other national, JCS, OSD and departmental boards, committees, and working groups concerned with intelligence.
6. Exercises overall coordination and direction in matters pertaining to foreign maritime doctrine, policy and strategy and the participation of Navy personnel in national intelligence committees, ensuring policy consistency and guidance as needed.
7. Supports and acts for OP-092 in providing advice and counsel to SECNAV, OPNAV, DOD, and component commanders concerning the foreign maritime threat.
8. Coordinates Navy intelligence participation in contingency and emergency planning, intelligence support to federal drug interdiction programs, and other policy and planning issues which impact on the Navy intelligence mission.
9. Acts as OP-092 in the absence of the DNI.

DEPUTY DIRECTOR FOR CRYPTOLOGY
OP-092C

Mission: To implement OP-092 responsibilities for formulating cryptologic plans and programs, and for integrating intelligence and cryptologic planning.

Functions:

1. OP-092C is additional duty for the Commander, Naval Security Group Command.
2. Coordinates mid- and long-range cryptologic planning in response to national and fleet requirements and ensures program responsiveness to intelligence and cryptologic planning.
3. Represents OP-092 on appropriate national, DOD, and departmental boards, committees, and working groups.
4. Performs program coordination for the Navy portion of the Tactical Cryptologic Program and the Consolidated Cryptologic Program.
5. Coordinates cryptologic activities within the Navy.
6. Coordinates the Cryptologic Direct Support Program and the Navy portion of the Consolidated Cryptologic Program, and presents and justifies these programs and supporting budgets, as required.
7. Advises OP-094 on signals security matters affecting COMNAVSECGRU.
8. Represents DON in and acts on Defense Courier Service matters.
9. Provides advice on the cryptologic implications of international politico-military matters and foreign military assistance, and advises OP-092 in matters concerning foreign release of systems, equipment, and information for which OP-092 is cognizant.
10. Advises and assists OP-07 in matters concerning cryptologic support to naval warfare.

DEPUTY DIRECTOR FOR INTELLIGENCE PRODUCTION
OP-092D

Mission: To implement OP-092 responsibilities for formulating collection and analysis plans and programs, and for integrating intelligence requirements with collection planning, analysis and dissemination.

Functions:

1. OP-092D is additional duty for the Commander, Naval Intelligence Command.
2. Coordinates mid- and long-range intelligence planning in response to national and fleet requirements and ensures program responsiveness.
3. Represents OP-092 on appropriate national, DOD, and departmental boards, committees, and working groups.
4. Coordinates overall responsibility and authority within the Navy in matters pertaining to intelligence requirements, collection, production, and dissemination.
5. Participates in the formulation, coordination, and evaluation of national, joint and naval intelligence estimates.
6. Assists in the formulation of policy with regard to the control, protection, dissemination and use of special intelligence and special activities materials within the Navy Department.

ASSISTANT FOR CURRENT INTELLIGENCE
OP-092H

Mission: To provide direct support to the DNI for the collection, processing, display, and dissemination of current intelligence information to the SECNAV, CNO, and DON staff elements.

Functions:

1. Maintains a continuous, all-source plot of worldwide military and geopolitical activity in support of the SECNAV, CNO, and DON components.
2. Provides direct intelligence support to the office of the Deputy Chief of Naval Operations (Plans, Policy, and Operations) (OP-06) for the planning and implementation of U.S. Navy contingency operational plans.
3. Maintains an intelligence briefing section for the production of daily formal and ad hoc operational intelligence briefings to the SECNAV, CNO, DNI, and DON staff elements.
4. Produces daily written intelligence summaries for distribution to the SECNAV, CNO, DON staff elements, and operational commands.
5. Serves as the Indications and Warning (I&W) facility for the CNO.
6. Maintains watches and plots as required to support OPNAV special operational tasking and missions.
7. Liaises directly with intelligence commands worldwide in order to fulfill assigned functions.
8. Represents OP-092 on appropriate boards, committees, and working groups as required.
9. Sponsors Naval Intelligence Reserve Unit INTEL PLOT 0166.

ASSISTANT FOR LEGAL MATTERS
OP-092J

Mission: To advise and assist the DNI in legal and legislative matters related to Naval Intelligence functions.

Functions:

1. Advises OP-092, his staff and other members of the Naval Intelligence community on legal issues related to intelligence policy and operations, personnel and personnel security matters; advises on contractual matters, military justice and other criminal matters.
2. Acts as the Executive Secretary of the DON's Intelligence Oversight Board and is primary action officer on Intelligence oversight matters.
3. Acts as the primary liaison between OP-092 and other government agencies on criminal investigations and prosecutions involving espionage and other national security offenses.
4. Acts as principal liaison with OLA and Congressional staffs on intelligence issues.

ASSISTANT FOR FOREIGN LIAISON
OP-092L

Mission: To act as the principal point of contact in the Navy for foreign naval attaches accredited to the Department of the Navy and to advise OP-092 on matters of protocol, foreign VIP visits and related matters.

Functions:

1. Acts as the principal point of contact within DON for all foreign attache matters.
2. Maintains liaison with foreign attaches in order to advise and assist them in matters relating to their official duties.
3. Arranges for courtesy calls on U.S. naval officials by foreign attaches and other foreign dignitaries.
4. Processes and coordinates requests for travel outside the Washington area by U.S.S.R. and Eastern European military personnel.
5. Coordinates with appropriate DOD offices and other governmental agencies on matters pertaining to liaison with foreign attaches.
6. Processes clearance requests for visits of foreign Navy ships to U.S. controlled ports.
7. Processes clearance requests for foreign military aircraft landing at U.S. naval facilities.
8. Provides guidance and assists members of the Navy Department on matters of protocol and naval customs and ceremonies.
9. Participates in preparing the list of projected guests of OP-092 and the CNO, and carries out all facets of the plans and arrangements for visits to the United States by official foreign guests of CNO, CJCS, SECNAV and SECDEF.
10. Prepares special correspondence and courtesy communiques for the SECNAV, CNO, and OP-092 for foreign national holidays and, when directed, appropriate messages of congratulations or condolences to distinguished foreign officials for all countries.
11. Assists Op-092 with arrangements for official social functions involving foreign guests.
12. Acts as primary point of contact in the Navy for liaison with foreign embassies.
13. Coordinates Navy Department portion of U.S. Information Agency (USIA) Distinguished Visitors Program.

ASSISTANT FOR INTERAGENCY COORDINATION
OP-092K

Mission: To advise and assist the DNI in carrying out assigned responsibilities for coordinating matters relating to sensitive and compartmented programs, intelligence support to naval special warfare forces, and the DON interface with other U.S. Government departments and agencies.

Functions:

1. Acts as the single focal point for coordinating sensitive support arrangements between the DON and other departments and agencies of the U.S. Government.
2. Assists the DNI in coordinating administrative matters within the intelligence community.
3. Assists the DNI in executing his responsibilities related to special access programs.
4. Assists the DNI in his responsibilities related to intelligence support to naval special warfare forces.

ASSISTANT FOR RESERVE AFFAIRS
OP-092R

Mission: To assist the DNI in his execution of all Naval Reserve matters and to act as the OPNAV point of contact for DNI reserve matters by maintaining close and continuing liaison with COMNAVINTCOM, COMNAVSECGRU, COMNAVSECINVCOM, DIRNAVRESINTPRO and other DoD/service intelligence communities on all reserve program matters.

Functions:

1. Advises the DNI on all reserve programmatic matters.
2. Develops OP-092 policy guidance concerning the mission and mobilization utilization of reserves.
3. Monitors reserve requirements and seeks their satisfaction in budgetary/manpower process.
4. Develops policy and monitors adequacy of standards for reserve mobilization training and readiness requirements.
5. Represents the DNI in all reserve forums within the DoN and with other defense agencies and services.
6. Develops and coordinates policy concerning reserve equipment, facilities and manpower requirements.
7. Represents DNRIP, COMNAVRESFOR and program technical managers within the DNI staff.
8. Reviews all recommendations to the DIRNAVRES concerning the development, location and organization of DNI-sponsored billets, units and other program structure.
9. Acts as point of contact for SSO Navy concerning security requirements for the reserve program.
10. Participates in POM consolidation meetings to ensure timely, accurate submissions of reserve intelligence resource requirements.
11. Develops and monitors policy and guidance concerning utilization of naval reserve personnel during mobilization, including mutual support tasking during peacetime.
12. Acts as OP-092 point of contact for NAVCRUITCOM concerning policy for reserve officer and enlisted recruiting requirements.
13. Acts as DNI point of contact for Reserve ACDUTRA scheduling, administrative, and training requirements.
14. Acts as DNI point of contact concerning reserve issues for those units/personnel assigned to mobilize and perform weekend drills within OP-092.

ASSISTANT FOR TECHNOLOGY
OP-092T

Mission: To provide technical expertise, advice, and staff support on the development, production and operation of intelligence collection, processing, analysis and dissemination systems, present and future, under OP-092.

Functions:

1. Maintains currency on technologies having intelligence applications. Evaluates, and provides technical guidance and advice for improvement of current and proposed systems.
2. Monitors R&D, production, test and evaluation for work in progress, judging cost effectiveness, timeliness, and technical merit.
3. Maintains technical liaison with Navy and DoD components, other government agencies, industrial organizations and academia.
4. Provides policy guidance, technical guidance, and staff support to approximately 25 Consultants to the Director of Naval Intelligence.
5. Participates in formulating Navy scientific and technical policies as they pertain to intelligence.
6. Conducts technology liaison with, and provides intelligence support to OP-098.
7. Represents OP-092 interests related to technology assessment and technology transfer issues. Provides oversight for Naval Intelligence Support Center input on these topics to OP-092.
8. Provides technical intelligence support and representation on DOD committees concerned with science and technology (e.g., Intelligence Research and Development Council).
9. Conducts liaison with other Navy, DOD, intelligence community, and interagency bodies and intelligence organizations concerned with foreign science and technology.
10. Develops and plans for analytical initiatives to enhance data collection and processing.
11. Provides guidance and staff support to the Advanced Technology Panel (ATP) of the CEB and the ATP Working Group.

ASSISTANT FOR JOINT NATIONAL
INTELLIGENCE DEVELOPMENT (JNID)
OP-092U

Mission: To rapidly apply advanced information systems technology to selected intelligence analysis problems and remedy shortfalls in the analytical process.

Functions:

1. Assists OP-092 in the guidance and direction of the JNID Staff where OP-092 is the Executive Agent.
2. Coordinates with members of the Oversight Board on issues dealing with development, funding or manpower and their impact on current, as well as future tasks.
3. Conducts functional analysis of intelligence analytical areas assigned by the Oversight Board, to identify problems and shortfalls.
4. Defines requirements for development of new technology prototype systems to alleviate the analytical problems and shortfalls.
5. Manages JNID resources; ensures budget submissions are adequate to accomplish projects. Coordinates process leading to contract awards.
6. Conducts feasibility studies related to project requirements and pertinent technologies.
7. Operates testbed facilities to evaluate prototype capabilities for rapid iterative development.
8. Develops prototype hardware and software analytical aids to amplify analytical capabilities or remedy technology shortfalls in intelligence analysts' systems.
9. Develops secure methodologies and analytical aids for sensitive compartmented data.

ASSISTANT FOR
FOREIGN COUNTERINTELLIGENCE
OP-092X

Mission: To develop policy with regard to foreign counterintelligence (including anti-terrorism).

Functions:

1. OP-092X is additional duty for the Commander, Naval Security and Investigative Command.
2. Develops policy for matters involving foreign counterintelligence (including anti-terrorism).
3. Serves as Navy program manager for counterintelligence and anti-terrorism.
4. Coordinates DON programs in areas related to the mission and presents and justifies those programs and supporting budgets as required.
5. Operates the Anti-terrorist Alert Center (ATAC) to provide Indications and Warning and analysis of terrorist actions which may affect DON operating forces and the shore establishment.
6. Represents OP-092 on appropriate national, DOD, and departmental boards, committees, and working groups.

ASSISTANT FOR SPECIAL SECURITY MATTERS
OP-092Z

Mission: To provide support and guidance to Navy elements (SECNAV, CNO, DNI and staffs) in the security management of national and Navy Sensitive Compartmented Information (SCI) programs; to provide SCI service and support to these agencies and to support DOD and certain other Navy and federal agencies for Navy participation regarding security management of national and Navy SCI programs and certain SCI services to fleet and COMNAVINTCOM commands.

Functions:

1. Serves as Special Security/SCI Control Officer, Chief of Naval Operations.
2. Acts as the DNI's principal SCI advisor to the SECNAV/USN, and Assistant SECNAV's, CNO/VCNO, and their staff offices, and certain other Navy commands under the administrative and security cognizance of the CNO SSO.
3. Serves as DNI coordinator with COMNAVINTCOM/Navy SSO representatives relative to SSO Navy participation in and contact with the Intelligence Community.
4. Promulgates guidance and instructions on matters concerning the security, control and utilization of SCI programs for designated commands/activities.
5. Administers the SECNAV/CNO SCI Personnel Security program.
6. Provides centralized management of SCI billets for certain SCI/SAP programs for the Navy Department billets located within the Pentagon.
7. Conducts surveys, investigations and inspections as required by DNI relative to physical accreditations, security violations or compromises, and special studies on SCI matters.
8. Coordinates SECNAV/OPNAV SCI security education and awareness program.
9. Manages the SECNAV/CNO SCI Administrative Officer (ADMINO)/Intelligence Liaison Officer (ILO) programs. Coordinates utilization and training of all designated ADMINO's/ILO's.

RESOURCE MANAGEMENT DIVISION
OP-920

Mission: To implement OP-092 responsibilities for all intelligence and cryptologic program and budget matters, to include Reserves, and all intelligence and cryptologic manpower, personnel and training matters.

Functions:

1. Serves as the responsible OP-092 division for all resource matters related to Department of the Navy funded programs for which OP-092 is resource sponsor. (Navy programs and resources include Navy Program II (General Purpose Forces); Program V (Reserves); Program VI (RDT&E); and Program VIII (Training).) (OP-920C, OP-920D))
2. Serves as the responsible OP-092 division for all resource matters related to DCI-funded programs from which funds are sub-allocated to Navy for execution, primarily to satisfy Navy requirements. (These programs include the General Defense Intelligence Program (GDIP), the Consolidated Cryptologic Program (CCP), Special Activities, Navy (SA,N) and the Foreign Counterintelligence Program (FCI).) (OP-920D)
3. Serves as the OPNAV functional sponsor for the development, test and evaluation, and acceptance for service use of systems funded by the CCP which are operated or maintained by naval personnel or which otherwise affect CCP support to the Navy. (OP-920D)
4. Serves as the Navy-wide coordinator for intelligence, cryptologic and intelligence-related programs for which sponsorship resides in OPNAV and/or for which at least some funding is provided for organizations external to Navy. (These programs include Tactical Intelligence and Related Activities (TIARA) and the Tactical Cryptologic Program (TCP).) (OP-920D)
5. Coordinates submission of the Navy intelligence and cryptologic programs and budgets to higher authority, including the justification of, and testimony on, same. (OP-920D)
6. Reviews and/or prepares program/requirements documentation for all programs. (OP-920D)
7. Maintains liaison with other OPNAV program and budget offices, resource sponsors, second echelon commands, other Services/Defense Agencies, the Office of the Secretary of Defense, and the Intelligence Committee (IC) Staff to ensure proper consideration of Navy intelligence and cryptologic programs. Represents the Navy to external organizations. (OP-920D)
8. Serves as the responsible OP-092 division for intelligence and cryptologic manpower and training plans, policy, and resource requirements for fleet and field activities. (OP-920C)

9. Liaises with Defense Agencies, other services, Navy resource sponsors, and second echelon commands concerning planning and policy requirements for intelligence and cryptologic manpower and training. (OP-920C)

INTELLIGENCE AND CRYPTOLOGIC
PLANS, POLICY, & REQUIREMENTS DIVISION
OP-921

Mission: To implement OP-092 responsibilities for formulating intelligence and cryptologic plans, policies and requirements; coordinating intelligence and cryptologic actions on Navy, interdepartmental, interagency, joint, national and international boards and committees; liaison with U.S. Marine Corps on intelligence and cryptologic matters; developing intelligence and cryptologic support to naval warfare requirements; coordinating C³I policy; participating in warfare appraisal process; and providing intelligence and cryptologic support to Electronic Warfare and C³CM.

3. Serves as the central point of contact within OP-092 for overall development and coordination of intelligence and cryptologic support to naval warfare, platform requirements and fleet operations. (OP-921R)
4. Serves as the OP-092 point of contact for matters concerning the development and employment of intelligence and cryptologic systems and techniques in support of naval operations. (OP-921R)
5. Serves as the cognizant OP-092 division for all electronic warfare and C³CM matters. (OP-921R)
6. Serves as the OPNAV coordinator and focal point for all Navy special security communication and related GENSER communications policy at tactical and shore nodes. (OP-921R)
7. Coordinates the review of DON and DOD plans, policy, and requirements statements for intelligence implication and ensures that cognizant OPNAV elements are informed of major policy decision/implications and JCS actions. (All OP-921 codes)
8. Serves collaterally as special assistant to the DNI and OP-092 staff and as point of contact for matters related to Marine Corps intelligence plans, policy and support requirements. (OP-921P)
9. Participates in the validation of operational requirements involving intelligence and cryptologic systems, applications and techniques. (OP-921R)

10. Acts as the OP-092 Intelligence Planner for applicable JCS actions. (OP-921P)
11. Serves as OP-092 JCS Support Office; coordinates and establishes procedures for JCS action matters within OP-092. (OP-921P)
12. Develops, coordinates, and recommends Navy objectives and priorities for SIGINT, MASINT, IMINT, and HUMINT systems. (OP-921P)
13. Provides policy guidance for Naval Intelligence actions in support of national intelligence plans and programs. (OP-921P)
14. Assists elements of the DON on technical and professional matters involving intelligence and cryptology. (All OP-921 codes)
15. Coordinates development of concepts of operations (CONOPS) for intelligence and cryptologic systems planned for Navy operational employment and related shore support. (OP-921R)
16. Serves as the OP-092 point of contact for all matters related to computer security (COMPUSEC), communications security (COMSEC), and the Navy Vulnerability Assessment Program (NVP). (OP-921R)
17. Represents OP-092 in all matters related to air and surface warfare support by intelligence and cryptologic resources. (OP-921R)
18. Coordinates with OP-922 on all matters related to submarine warfare support by intelligence and cryptologic resources. (OP-921R)
19. Coordinates OP-092 support to naval warfare requirements and appraisals processes. (OP-921R)
20. Sponsors Naval Intelligence Reserve Unit - OPNAV NR 092 INTELL PLANS 0166. (OP-921P)
21. Coordinates intelligence production and dissemination policy guidelines for special programs. (OP-921P)
22. Coordinates foreign intelligence exchange programs. (OP-921P)

INTELLIGENCE ANALYSIS DIVISION
OP-922

Mission: To implement DNI responsibilities for formulating, coordinating and evaluating international, national, joint and naval intelligence estimates and the production of other substantive foreign intelligence analyses and assessments.

Functions:

1. Acts as OP-092 point of contact and represents the Director of Naval Intelligence on matters pertaining to DON, DOD, national and international estimates; participates in the preparation, coordination and evaluation of such estimates. (OP-922, OP-922Y, OP-922F)
2. Provides to SECNAV/OPNAV offices, and other consumers as required, in-depth intelligence analyses and time sensitive evaluations of worldwide political-military, economic and technological developments; coordinates other naval intelligence analytical activities on these subjects as required. (OPs-922, 922Y, 922F)
3. Provides analytical support to SECNAV/OPNAV offices and other appropriate consumers on matters relating to threat statements and projections of military capabilities for all aspects of foreign naval warfare; assists Navy consumers in developing data on these subjects for OPNAV-sponsored analytic projects. (OP-922, OP-922F, OP-922Y)
4. Provides OP-092 staffing for MIB/NFIB, JCS, Congressional, news media and other external agency actions dealing with substantive foreign intelligence matters. Prepares the annual DNI Posture Statement to Congress and supports, as required, other DNI appearances before Congress, the news media and the general public on substantive foreign intelligence subjects. (OPs-922, 922Y, 922F)
5. Represents OP-092, as appropriate, on DoN, DOD, national and international committees, working groups and policy boards and at national and international conferences related to substantive foreign intelligence matters. (OP-922, OP-922F, OP-922Y)
6. Maintains OP-092's principal intelligence publications library. (OP-922Y)
7. Produces and updates OPNAV's Understanding Soviet Naval Developments publication. (OP-922F)
8. Acts as "Gaining Command" for the analytic activities of CNO ANALYSIS Reserve Unit 0166, including management of ONI's Naval Intelligence Quarterly publication. (OP-922, OP-922F, OP-922Y)

OPERATIONAL SUPPORT DIVISION
OP-923

Mission: To coordinate and implement OP-092 responsibilities for operational support to U.S. and allied intelligence collection activities.

Functions:

1. Advises and assists the DNI with OP-092 responsibilities pertaining to fleet operations for collection of intelligence in fulfillment of national, DOD and Navy requirements. (OP-923)
2. Coordinates and supports specified collection, production, and dissemination activities as authorized by DIA and JCS. (OP-923C, OP-923D, OP-923E, OP-923F)
3. In coordination with other government agencies, maintains, develops and supports collection actions, plans, and programs related to naval intelligence. (OP-923D, OP-923E)
4. Acts as principal coordinator for planning, operational and R&D requirements and data handling functions for fleet intelligence programs, performing liaison and collaboration with various government agencies. (OP-923D, OP-923E, OP-923F)
5. Coordinates preparation and promulgation of doctrine, guidance, and directives for the acquisition, production and dissemination of compartmented intelligence. (OP-923D, OP-923F, OP-923G)
6. Develops and promulgates guidance on security safeguards and procedures for compartmented intelligence programs, equipment, data and products. (OP-923C, OP-923F, OP-923G)
7. Coordinates within OP-092 and is specific point of contact for all matters related to Submarine Warfare support by intelligence and cryptologic resources. (OP-923D, OP-923F)
8. Develops, coordinates and promulgates requirements for technical sensors for operational support projects. Assists OP-924 in development of the Navy budget program element for these sensors. (OP-923D, OP-923E, OP-923F)

RESEARCH AND DEVELOPMENT REQUIREMENTS DIVISION
OP-924

Mission: To advise, coordinate, sponsor, and monitor requirements for sensor systems, subsystems, intelligence processing upgrades and equipment under the cognizance of OP-092.

Functions:

1. Assists in identifying requirements for intelligence sensor systems and equipment and coordinates preparation of required documentation to support development. (OP-924)
2. Reviews operational intelligence sensor systems and equipment and acts to correct deficiencies. (OP-924)
3. Defines guidelines that can be used to evaluate the expected effectiveness of intelligence systems and equipments. (OP-924)
4. Evaluates intelligence system and equipment proposals to determine the most effective approach to satisfy intelligence requirements. (OP-924)
5. Exercises OP-092 responsibility for developing coordination and appraising selected programs involving intelligence sensors and sensor systems. (OP-924)
6. Sponsors, directs, and monitors system and equipment requirements. (OP-924)
7. Prepares and coordinates requisite resource documentation and justification to support intelligence system R&D and procurement. (OP-924)
8. Ensures system and equipment interface compatibility. Coordinates between Navy and other services or agencies, particularly the analysis community, to ensure proper understanding of system and equipment capability, calibration and operations. (OP-924)
9. Coordinates use of intelligence systems and equipments with fleet personnel. (OP-924)
10. Serves as OP-092 primary liaison with OP-987 for RDT&E intelligence requirements. (OP-924)
11. Advises OP-092 on programs and sensors under OP-092 cognizance that relate to programs of mutual interest with OP-07 and other appropriate offices of the DON and DOD. (OP-924)
12. Serves as primary OP-092 liaison with the R&D organizations of other intelligence agencies. Participates in deliberations and activities of interdepartmental, DOD, and joint service boards and committees on intelligence RDT&E requirements matters. (OP-924)

13. Serves as other OP-092 focal point for threat support, and provides liaison with the SYSCOMs and OPNAV offices regarding weapon system acquisition issues. (OP-924)
