1. At the SRE discussion on Aug 5, 1952 with the Senate Judiciary Sub-Committee on Refugees and Escapees, a member of this Mission's staff represented the Mission and the Embassy. The only specific reference to France during this discussion was Ambassador Draper's expression of confidence that, among other European countries, France could accept refugees or other unemployed persons if the numbers were not excessive. There was no separate discussion on France between the Committee and the Mission.

2. Mission comments on the general question of manpower movements as related to France, with specific reference to the problem raised in Paris Repto A-27, August 8, 1952, will be shortly forthcoming.
