SUBJECT: DDCI appearance before the House Permanent Select  
Committee (HPSCI) regarding Arms Control

1. On 8 June 1988, the DDCI testified before HPSCI on the understanding between the Administration and the Senate concerning new initiatives [redacted]

All Members except Mr. Dwyer and Mr. Foley had questions. The DDCI testimony and the Members' questions and answers are all covered in the transcript.

3. There were no action items to be followed up by the Intelligence Community. Mr. Hyde did secure Committee approval to submit written questions. The Intelligence Community's answers will be included in the transcript.
