- **NSDD-95 CREATED TWO INTERAGENCY BODIES TO PROVIDE FOR POLICY AND PROGRAMMATIC OVERSIGHT:**
  - **CIMS REVIEW GROUP (CHAired BY APNSA)**
  - **CMWG (CHAired BY "AN NSC STAFF MEMBER")**
- **COLIN POWELL APPROVED MODIFICATION IN MAY 1987 WHICH:**
  - **REASSIGNED CIMSRG FUNCTIONS TO PRG**
  - **APPOINTED DES/SS, NSC AS CHAIRMAN OF CMWG**
- **SINCE MAY 1987, CMWG HAS MET FOUR TIMES**
- **PRG HAS NEVER MET OVER "CRISIS MANAGEMENT" POLICY ISSUES**
- **KEY ROLE: COORDINATION & POLICY OVERSIGHT**

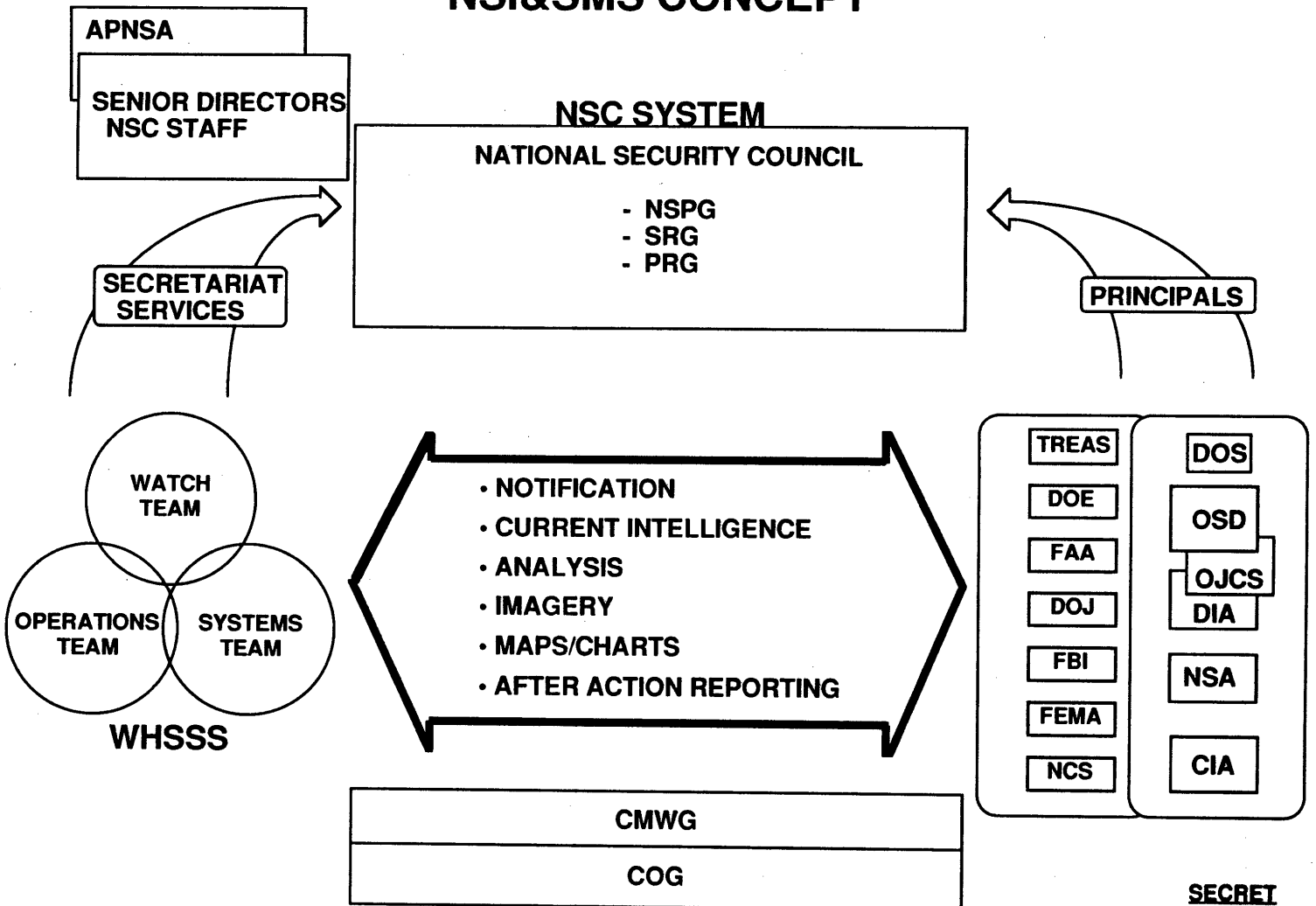
## **NOTIONAL DEFINITION: NATIONAL SECURITY INFORMATION & SITUATION MANAGEMENT SYSTEM (NSI&SMS)**

**An interagency network of people, facilities, equipment, information resources, plans, policies and procedures designed to provide for: (1) a continuous flow of information regarding national security situations throughout the globe and across a spectrum from peacetime activity through reconstitution following nuclear attack, and (2) support to national-level decision makers in monitoring national security situations and in considering, implementing, or reporting on any U.S. response.**

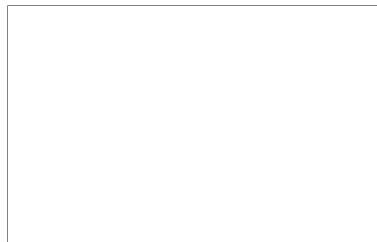

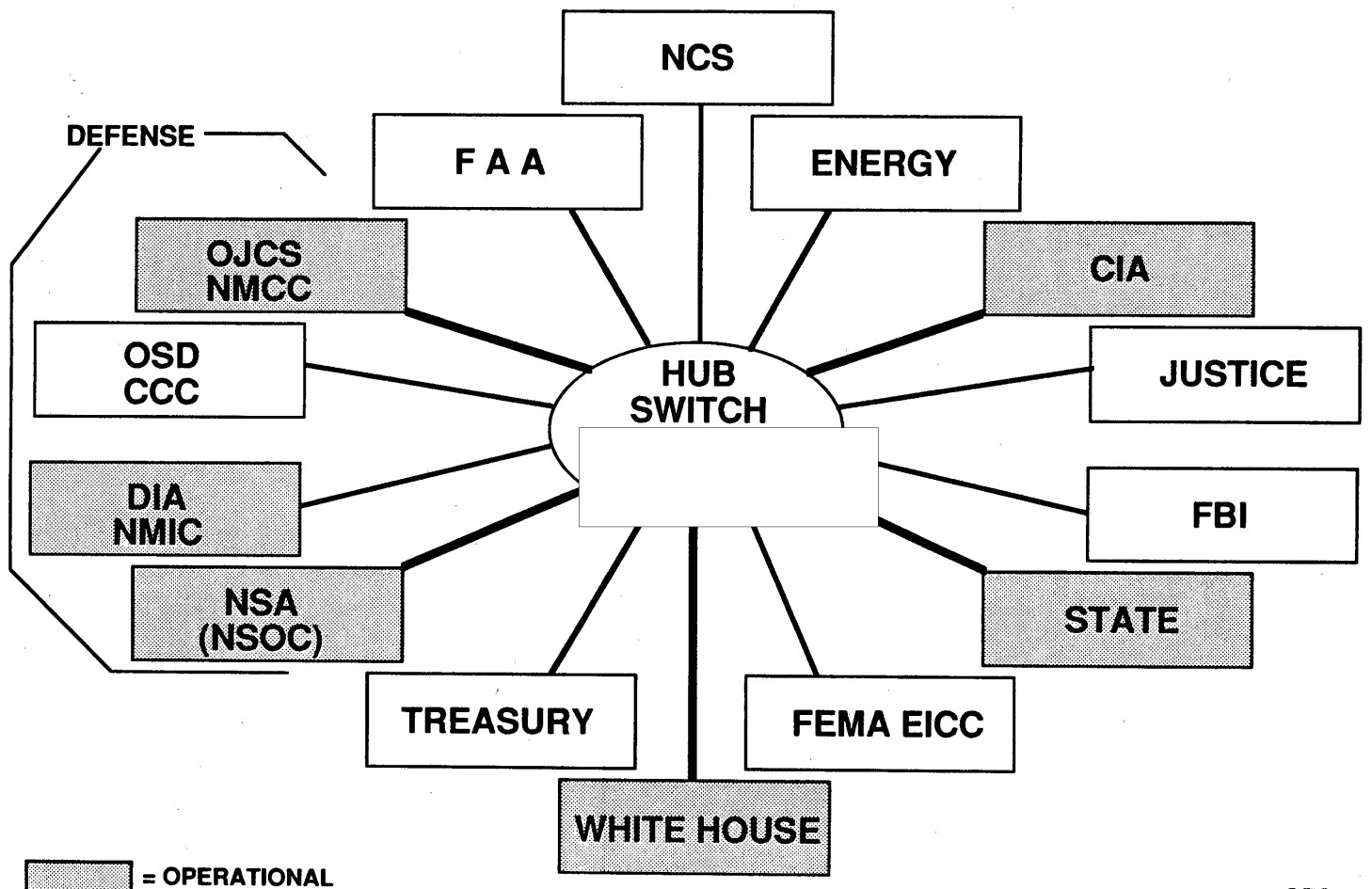
