MEMORANDUM FOR: Deputy to the DCI for National Intelligence Officers

SUBJECT : SSC Request for KIQs and KIQ Strategy Reports

1. Reference is the attached memorandum from William Miller, SSC Staff Director, requesting delivery to the SSC of the 1975 KIQs and five KIQ Strategy Reports (#7, 22, 30, 37 and 52), all of which I understand have been examined by SSC Staff members in your office.
