BEREZA AIRFIELD, USSR (SWN)

1. SIGNIFICANCE: THIS WAS THE FIRST OBSERVATION OF BOTH FLANKER AND FULCRUM TOGETHER AT AN OPERATIONAL AIRFIELD. (SWN)

2. REMARKS: TWO FLANKER A MODIFIED, ONE FLANKER A, AND TWO FULCRUM A (PROBABLY IN TRANSIT) WERE AT BEREZA AIRFIELD ON [REDACTED] THE AIRCRAFT WERE NOT PRESENT [REDACTED] BOTH OF THE FLANKER A MODIFIED (GRAPHIC 1) WERE ON THE PARKING/FUELING APRON WITH GROUND SERVICE VEHICLES NEARBY AND HAD UNIDENTIFIED OBJECTS (POSSIBLY PYLONS) UNDER EACH WINGTIP. ONE FLANKER A MODIFIED HAD A TWO-TONE PAINT SCHEME. THE FLANKER A (GRAPHIC 2) HAD UNIDENTIFIED OBJECTS (POSSIBLY PYLONS) MID-MOUNTED UNDER THE WING AND WAS IN A DISPERSAL AREA WITH THE TWO FULCRUM A. BEREZA AIRFIELD SUPPORTS A FISHBED J/K REGIMENT IN THE BELORUSSIAN MILITARY DISTRICT (MD). SIX FISHBED WERE PRESENT [REDACTED] AT THIS HARDENED AIRCRAFT SHELTER-EQUIPPED AIRFIELD. (SWN)
