1. Permission has been granted to use TALENT materials on a sanitized basis with the below listed consultants on 15-16 May:

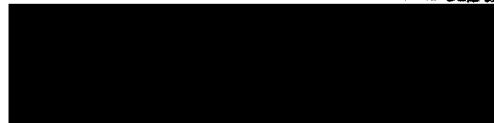

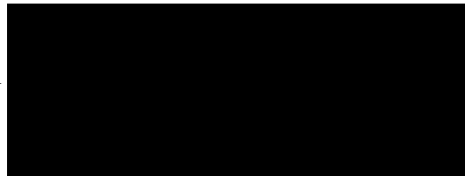

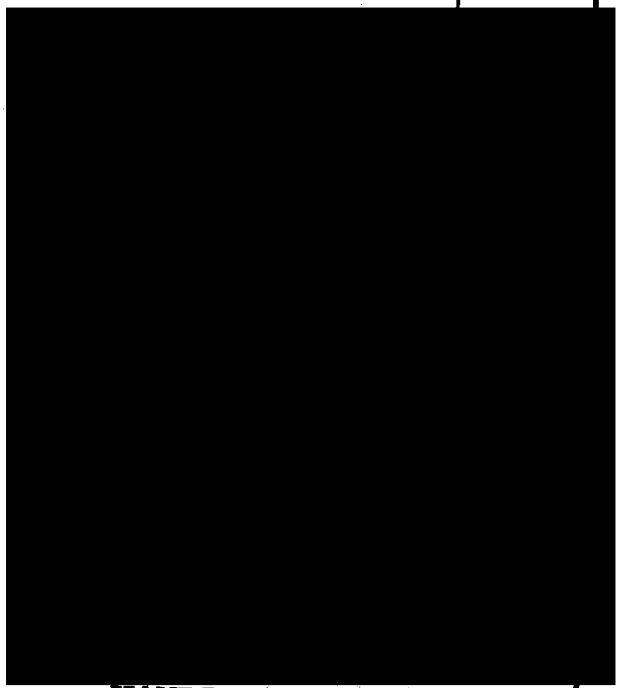
