Attached is a list of our visitors from the House Post Office and Civil Service Committee who will be with us on Thursday, 31 August.

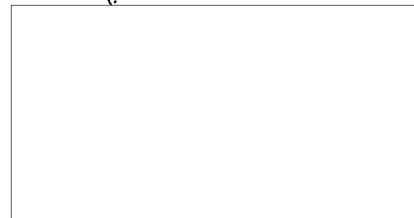

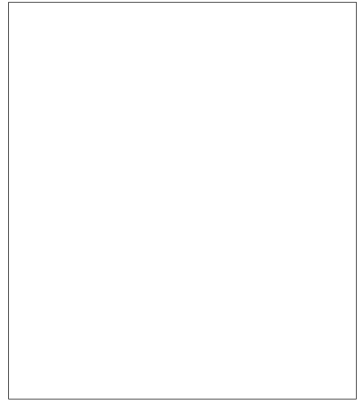
