(S) IN RECENT DISCUSSION WITH OTS REGARDING STANFORD RESEARCH INSTITUTE (SRI) INVESTIGATIONS ON REMOTE SENSING, WE WERE INFORMED OF AN OTS PUBLISHED STUDY RELATED TO THIS EFFORT, OUR OFFICE IS INVESTIGATING INTELLIGENCE ESTIMATES REGARDING POSSIBLE USSR APPLICATIONS OF SUCH A TECHNIQUE AND WE ARE ALSO CONSIDERING CONTRACTUAL WORK WITH SRI FOR REVIEW OF USSR LITERATURE THAT COULD BE RELATED TO THIS TOPIC, THIS EFFORT WITH SRI COULD ALSO INCLUDE INVESTIGATIONS INTO FEASIBILITY AND R/D ASPECTS OF THIS TECHNIQUE. THEREFORE WE BELIEVE YOUR STUDY, AND ANY EVALUATION OF THE RESULTS, WOULD BE HIGHLY BENEFICIAL IN ASSISTING OUR REVIEW AND WOULD HAVE A DIRECT IMPACT ON SCOPE OF ANY TASKING WE MIGHT NEGOTIATE WITH SRI. WE ALSO PLAN TO SHARE WITH YOU RESULTS FROM THIS POSSIBLE EFFORT IN THE HOPE IT WOULD BENEFIT YOUR OWN FUTURE INVESTIGATIONS.
