SUBJECT: ARMY POLICY GUIDANCE RE REQUESTS FOR INFO--GRILL FLAME (U)  
1. (S) PREVIOUS ESTABLISHED POLICY IS THAT ARMY ELEMENTS ARE NOT TO RESPOND DIRECTLY TO ANY REQUEST FOR GRILL FLAME INFO, OUTSIDE THE DOO FRAMEWORK. APPROPRIATE CHANNEL FOR SUCH REQUESTS WAS DESIGNATED TO THE ARDA STAFF OFFICE OF RESPONSIBILITY (DAMI-ISH). IN ORDER TO MAINTAIN MINIMUM STAFF COGNIZANCE, AVOID UNNECESSARY DUPLICATION, AND GENERALLY ACT AS A CLEARING HOUSE, THIS SAME POLICY HAS BEEN EXTENDED TO ALL ELEMENTS OUTSIDE ARMY. REQUESTS FOR SPECIAL BRIEFINGS,

PROPOSED JOINT EXERCISES, ETC, MUST BE COORDINATED WITH DAMI-ISH.

INFORMAL DISCUSSIONS AT THE ACTION OFFICER LEVEL, ARMY-TO-ARMY TALKS,  
OR OTHER SUCH ACTIVITIES WHICH HAVE BEEN COORDINATED THRU DAMI-ISH  
AND ARE DETERMINED TO BE OUTSIDE THE MEANING OF SPECIAL REQUESTS.  
AN EXAMPLE OF THE LATTER WOULD BE JOINT EXERCISES BETWEEN INSCOM AND  
USAF FTD, WHICH WERE PREVIOUSLY COORDINATED AND APPROVED.
