- (S/ORCON) DISCUSSION:
  - The 18 Sep 78 suspense established by Dr. Vorona's letter was extended to the first week of October by the DIA A/O, [REDACTED] SG1J
  - It is not reasonable for OACSI to recommend funding levels until INSCOM has designated its GF focal point, and the Working Group has been formed and met.
  - The most recent indication that Navy may still be working on GRILL FLAME was a remark made by one of the SRI scientists. He indicated that his office nearly lost a contract because of a novel published by SRI's main Subject.
