- 1. (S/NOFURN) This report provides documentation of a remote viewing session conducted for training purposes only.

#25: Kind of flat, concrete type structure and a dome, it's low, wooden building, white color, white fence, wooden fence around it. It reminds me of a stable. An aerial view of it...Open land,....

#25: Shaped like a (mumble) comb. Modern cone,(mumble), that we know of, no trees, not near the mountain, but near an ocean. And I get a sheer drop off near the deep ravine, can't see the bottom or side.

#66: No.



#25: That's all.




