(S/NF/SS-2) This request is in response to your desire for annual review of the DIA psychoenergetics activity conducted under SUN STREAK, a DoD-approved special access program.

(S/NF/SS-2) During FY 87, the 11 people assigned to Project SUN STREAK pursued the practical applications of applied psychoenergetics against selected operational tasks and improved skills through proven training techniques.

(S/NF/SS-2) During FY 88, proven training techniques will be continued and a wider range of operational tasks will be pursued for cueing Intelligence Community sources in the collection of foreign intelligence.

(S/NF/SS-2) The SUN STREAK Project Tasking Group comprised of a panel of senior executives from DIA, CIA, AIA, AF/IN, DNI and C³I oversees and advises in matters relating to operational concerns. Project activity is monitored and reviewed by an executive-level panel which includes ASDC³I and DR/DIA.
