1. (S/NF/SK) TASKIN<u>G: The Monitor was cognizant of the true</u> purpose of the site,

One room, a larger area, is allegedly a general work/discussion area, while the other, a much smaller room, is apparently restricted to only the most senior members of the This room is probably used for high level briefings and private discussions. Source was told only that this is a recurring requirement that has been targeted by other Remote Viewers (RV) in this unit in the past. Additionally, Source was provided with encrypted coordinates of this site, as per Coordinate Remote Viewing protocols, to read 112170/018605, thus preventing inadvertent geographic cuing. Prior to each session Source was provided the opportunity to review the highlights of His previous sessions before beginning the actual session. Source declined to do so and in lieu of this Source was told simply that this was, "the odd shaped building in the snow covered area you visited before", which were direct quotes from Source's initial session.

2. (S/NF/SK) SESSION: During each of the two sessions covered in this report, there were no reportable anomalies or incidents which may have affected or influenced the data provided by Source.

3. (S/NF/SK) SUMMARY:

(S/NF/SK) In the course of each session Source prepared a written summary of His impressions. The key components of these summaries have been combined and provided in an editorialized form

for clarity and order. The unabridged version of each of these summaries and all other Source/Monitor notes are maintained in the mission field dossier at this unit.

BEGIN COMPILATION OF SUMMARIES: "An impression of a room containing so many tables that it almost appears to have a 2nd or false floor....(at the) entrance area (it) is dark because there's no window light. Other areas (are) lighter and ${\color{red} { ext{seem}}}$ (sic) to have windows on both sides. The far end of the room is "blank". building seems to be only as wide as the room in this place. perceptions make me wonder why this room would be of special interest. There seems to be only cabinets on one side of a room full of empty tables at the present time and a few people sitting around quietly. At the far end of the room between the tables and the "blank wall", there is a person at a desk (sitting) before an enclosed separated area. This main room, the tabled area, has windows on both sides and takes up the entire width of the building at this point....Sunlight outside the building is always low on the horizon (making me feel that this) is very far north... (There is) a feeling for attraction to one person who must be approached by going past another person. This other person fives an "avoidance" feeling....(The) general overall feeling is of people who are serious and businesslike in their work but who seem very easy in it and enjoy doing it. (There) is no tenseness - just an "easy" ambience....(An adjoining area) leads into what appears to be an officials office (with) wood polish smells, warmth etc....(The outside area) is where activity takes place. Sounds of rustling, shuffling, background noises, a smell of fresh peanuts (sic), etc....(There is) an overall impression of a bright blue color to the room.... " END OF COMPILATION SUMMARY.

- b. (S/NF/SK) In addition to the information found in the above cited summaries, Source provided other data throughout the sessions which may be beneficial to the overall analysis of the information provided in this report. Key elements of, with explanatory notes when required, were as follows:
- 1) (S/NF/SK) People within this building were perceived by Source in many terms including: "nervous, tense, impatient, thoughtful, engrossed, educated, concentrating, business suits, and wearing grey and black textured "scratchy" (fabrics)".
- 2) (S/NF/SK) Early in the initial session covered in this report, Source sketched a complicated maze of hallways, stairs and passageways as n example of His impressions of the interior of the target building. (SEE PAGE 2, SESSION 2 OF SOURCE NOTES). Accompanying this sketch were words and phrases including: "warm, over heated, narrow, wood, close, old" and an AOL impression of "like I should be quiet here". Subsequent descriptors included,

"tiered, steep, wide, carpeted" and unusual, albeit insightful concept of, "a refusal or real hesitancy to go any further (in the building)".

- 3) (S/NF/SK) When specifically directed to move to, "the area of special interest", (ostensibly the actual targeting area within the building), Source described a room filled with desks and cabinets and a strong smell of xylene, a special cleaning solvent used normally for lenses and scopes, etc. Source had a strong AOL drive of a hospital ward at this point, perhaps caused by the impression of the smell of xylene, the tables lined in the room or some other unknown factor. A Stage VI sketch at this point revealed the site to be generally rectangular in shape with numerous rectangular objects in rows within the room. At one end of the room there is the "hint" of the sought after "second room". (SEE PAGE 15, SESSION 2 OF SOURCE NOTES).
- (S/NF/SK) The strong impression that Source had of a hospital ward had to be worked out to permit Him to continue in the session. That is to say, the validity of these impressions had to be examined and compared against the actual impressions that Source was receiving from the target. Once this, "working out" process was completed, Source was re-directed to the target area utilizing a specific "address", i.e., corridor 4, floor 5 of the structure. At the time He was told that the existence of a hospital ward may or may not be a reality in this large structure. It was more important for Source to realize that the ward, if existent, was not of primary interest at this time and that He was to focus His attention to the specific "address" given above. NOTE: In terms of the Remote Viewing phenomena, the "ward" and the actual target may have been one in the same. The technique utilized above was an effort to "clarify" a confusing image in Source's mind without undue cuing.
- 5) (S/NF/SK) Following the technique cited above, Source began describing the target area with seemingly more pertinent terminology, i.e., "conference area, quiet, people sounds, compartmented, businesslike, formal and friendly". Other strong impressions included a, "smell of wool" (perhaps a reference to the known presence of uniforms), "official" and "rules and regulations". At this point it was decided by Monitor that it would advantageous to terminate this session to permit the earlier impressions of the hospital ward to vanish completely.
- 4. (S/NF/SK) OPS FEEDBACK: Source was mildly admonished in the post-session interview for permitting Himself to fall victim to AOL drives and "peacocking". He was cautioned that, "not all targets will deal with high tech sites and that He should not attempt to draw in those images if they do not exist". It will have to wait

to be seen in subsequent session whether this "firm handed" approach is successful in overcoming Source's natural propensity to describe objects in high-tech terms. His personality is such that a negative aspect of this approach may be His resistance to criticism and a subsequent "refusal" to view the target in an informative and pertinent manner. It is planned that this Source will be given one more session at this target to firmly establish the "address" and general gestalts of the site when it is functioning. Presuming that Source is successful in this endeavor, He will be re-targeted to this facility sporadically in the future in an effort by this unit to "keep tabs" on this very strategic site.
