

SELF-EVALUATION: I don't know how much of this was AOL, driven by the fact that I accepted the first impressions of the site, which came sooner and clearer than is usual. These first impressions were more on the vague visual level, but I am finding that that seems to be customary with the sealed envelopes, so it is beginning not to bother me so much.

Perceptions "felt" right throughout the session, so I would personally place some credence in it, but always with the skepticism which comes from the knowledge of how sneaky and powerful AOL can be.
