The specific target was a special private room adjacent to a larger "operations type room" in which the senior members of the meet to discuss various matters in relative privacy and in a more informal manner. For the last several months other commitments have prevented continued exploitation of this facility. More recently an effort has been made to rejuvenate this target. In a recent session with another Monitor, Source was provided this mission with mixed and ambiguous results indicative of a general site acquisition, however the actual target, located was bypassed. 2. (S/NF/SK) SOURCE TASKING: Source was told that this was a continuation of a target that, "...you have worked before. In the previous session, indications are that you may have permitted other more interesting gestalts to detour you away from the actual target. You will therefore, have to know that there are other distractions in the area totally unrelated to the target. If I task you to re-focus or to leave an area it will be because I believe you are at the wrong area". Additionally Source was provided the same encrypted coordinates as the initial session, 112170/018605, as per Coordinate Remote Viewing (ERV) protocols. No other cuing or descriptive data was provided to Source prior to the session.

3. (S/NF/SK) INCLEMENCIES: There were no reportable incidents or anomalies which may have influenced the data obtained in this session. This was the first time in over three months that this Source was matched with this Monitor in a formal session. Very often the introduction of a new Monitor can upset the rhythm established by the "regular" Monitor and the Source. In this case there were some incidents where the Monitor imposed his versions of the accepted protocols and in other cases it was obvious that the Monitor was waiting for the Monitor to make some remark or action so that the session could continue. After a few such moments of uneasiness, the session seemed to progress smoothly and in the opinion of the Monitor, successfully.

4. (S/NF/SK) SUMMARY: Source furnished the attached summary which was prepared following the session and submitted to the Interviewer within 24 hours after the session. The completeness of the typewritten summary has been compared to the Interviewer's notes and all omissions, changes, and/or corrections have been verified as acceptable by the Interviewer. The information provided in the summary was found to be complete and did not require further modification, clarification or additions by the Interviewer.


5. (S/NF/SK) COMMENTS: Although Source has previously reported on this target, his previous session seemed to indicate more of
