AT FIRST I SAW THE OBJECT MOVING IN A NEW LOCATION. THIS LOCATION WAS NOT LIKE THE FIRST LOCATION I SPOKE ABOUT. THIS AREA WAS IN HIGHER LANDS AND THE AIR WAS CLEARER AND IT WAS BREEZY. I DID NOT FEEL AS HOT LIKE I DID IN THE FIRST LOCATION. THIS LOCATION HOWEVER WAS MORE OPENED AND SPACIOUS AND THE MEN WERE CONCERNED ABOUT BEING HERE. THEY WERE ~~AFRAID OF BEING~~ DETECTED FROM OVERHEAD.; THEY WERE MOVING FAST OR WANTING TO MOVE FAST TO GET OUT OF THIS AREA. I COULD SEE THE OBJECT IN A PORTABLE, MOVEABLE SHELTER. THE SHELTER WAS ~~ON A LONG, LOW, FLAT~~ ~~BEING DRIVEN~~. THE OBJECT AND MEN WOULD NOT BE STAYING HERE DUE TO THE OPENNESS OF THE AREA.

IN AUGUST, I PLACED THE OBJECT NEAR THE COASTAL AREA FACING THE WATER. THIS AREA WILL BE ~~NEAR THE EDGES OF THE~~ LAND AND NOT SO CENTERED IN THE LAND LIKE BEFORE. THE MEN WILL BE BUSY FIXING AND ADJUSTING THE OBJECT. THEY WILL MAKE SMALL ADJUSTMENTS AND I COULD SEE THAT THEY WERE CONCERNED WITH THE TOP OF THE OBJECT AND NOT SO CONCERNED WITH THE FRAMEWORK. I COULD SEE A MAN SITTING NEAR THE OBJECT AND HE WAS STUDYING THE OBJECT. I COULD SEE THE OTHER OBJECTS LIKE THIS OBJECT SITTING AT DISTANCES. THEY WERE PLACED SO THAT THEY FACED EACH OTHER AND THEY ENGULFED A CERTAIN LARGE AREA. ~~I COULD SEE A LIGHT ENCIRCLING A LARGE AREA~~ AND THE LIGHT WAS CAUSED FROM ALL OF THESE OBJECTS BEING USED AT THE SAME TIME. ALSO, EACH OBJECT IS AWARE OF THE OTHER OBJECT BEING USED. I COULD SEE MEN AT EACH LOCATION TAKING NOTES. THERE WAS A SENSE

OF COMPLETION. ALSO, THESE OBJECTS WORKED AT NIGHT.

IN SEPTEMBER, I COULD SEE ALL THE OBJECTS CLOSER TOGETHER AND BEING CONNECTED TO A CENTRAL CORE. THIS WAS A BIG DIFFERENCE COMPARED TO THE AUGUST TIME FRAME. THE OBJECTS WILL BE OPERATING AS A MUCH LARGER SINGULAR OBJECT. THERE WAS A FAST ROTATING MOVEMENT. DURING THIS TIME FRAME, THE MOVEMENT WAS FASTER.

I SENSED THAT THIS OBJECT WAS FULLY OPERATIONAL AND WORKING WELL. I COULD SEE OTHER OBJECTS AROUND THIS OBJECT IN A VERY LARGE AREA. IT WAS LIKE I WAS AT A CARNIVAL AND I WAS LOOKING DOWN AT ALL THE ACTIVITY. I COULD SEE EGG-SHAPED OBJECTS AND OVAL SHAPED OBJECTS AND FLAT OBJECTS. IT WAS TOO MUCH TO TAKE IN ALL AT ONE TIME. I SENSED HIGH LEVELS OF ENERGY. VERY HIGH LEVELS OF ENERGY. IT WAS LIKE BEING HIT BY A MICROWAVE AND IT WHACKED MY PHYSICAL BODY AND MADE ME FEEL FUNNY. THIS WAS AN EXTREMELY BUSY AREA AND THESE OBJECTS ARE TO BE USED IN CONJUNCTION WITH THE MAIN OBJECT BUT I DON'T KNOW FOR SURE IF THEY ARE OTHER SYSTEMS. I FELT THAT THE OBJECT WAS FIXED HERE. THE JOB OF THE OBJECT WAS TO MEASURE DISTANCES, VIEW OUT AND I GOT THE IMPRESSION OF HOLDING PATTERNS.

I THEN FELT THAT THERE WAS AN ISOLATED INCIDENT. I FELT THAT THERE WAS A TRIGGER AND THEN THERE WAS A LARGE THICK WHITE LIGHT FLYING ACROSS A NAVY BLUE SKY. THE LIGHT HIT A PLATFORM AND THEN THE LIGHT BOUNCED BACK INTO THE SKY AND DISAPPEARED. I FELT THERE WAS AN EXPLOSION AND IN A CONTAINED AREA I COULD SEE LARGE FLAMES. THE FIRE WAS CONTROLLED AND I SENSED NO HARM TO ANYONE. ALSO, AT THIS POINT I COULD FEEL AND SEE PLASTICS.
