3. BACKGROUND: Target is a probable narcotics smuggling mothership with the call sign ~~SECRET~~ SG1A. Between 0800-1100 hours on 5 April 1990, it was believed to be located in an area south of Haiti, at geographical coordinates 12 06' N 73 07' W. It is believed to be heading to rendezvous with U/I associates to engage in a surface transfer and/or unload provisions.

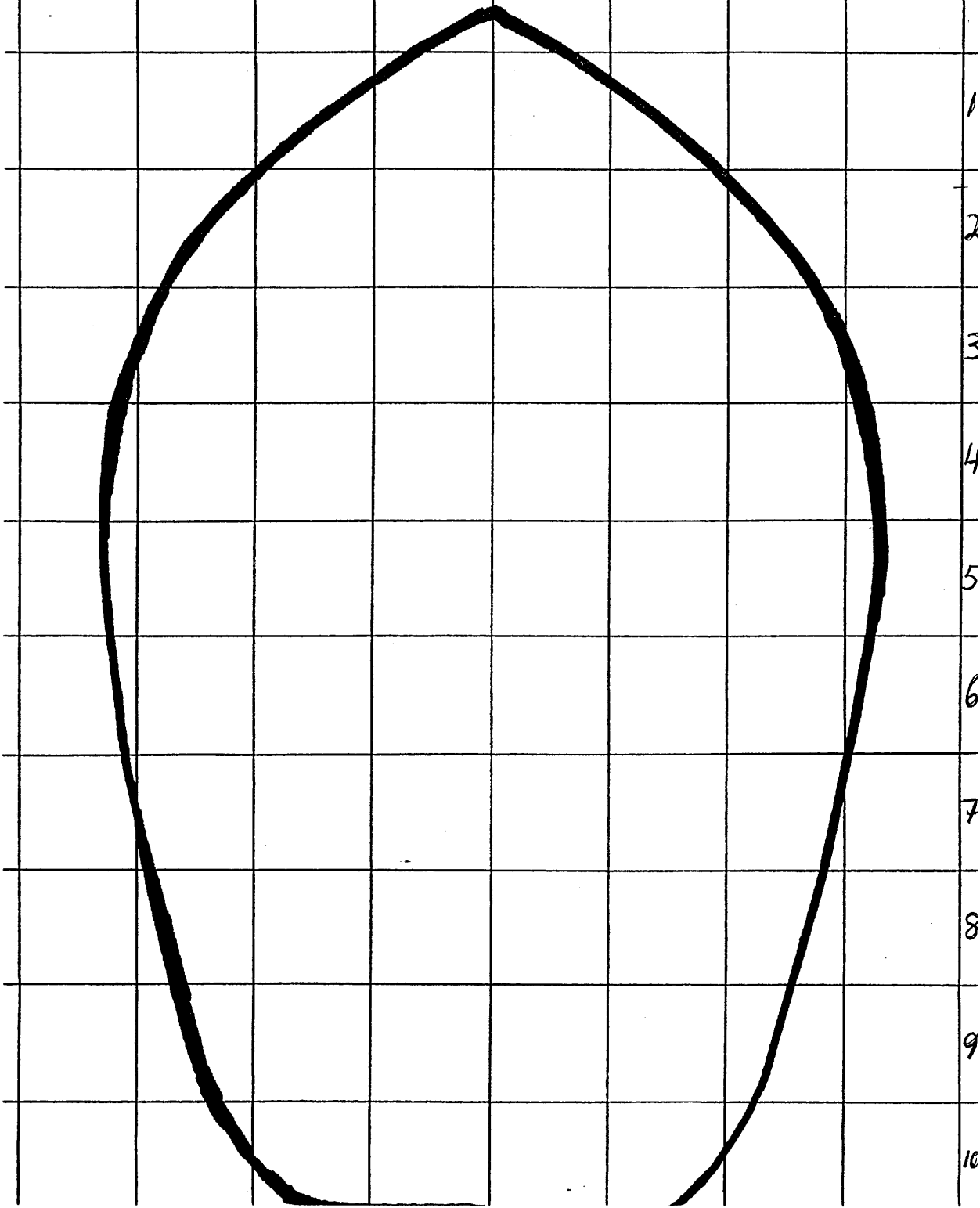

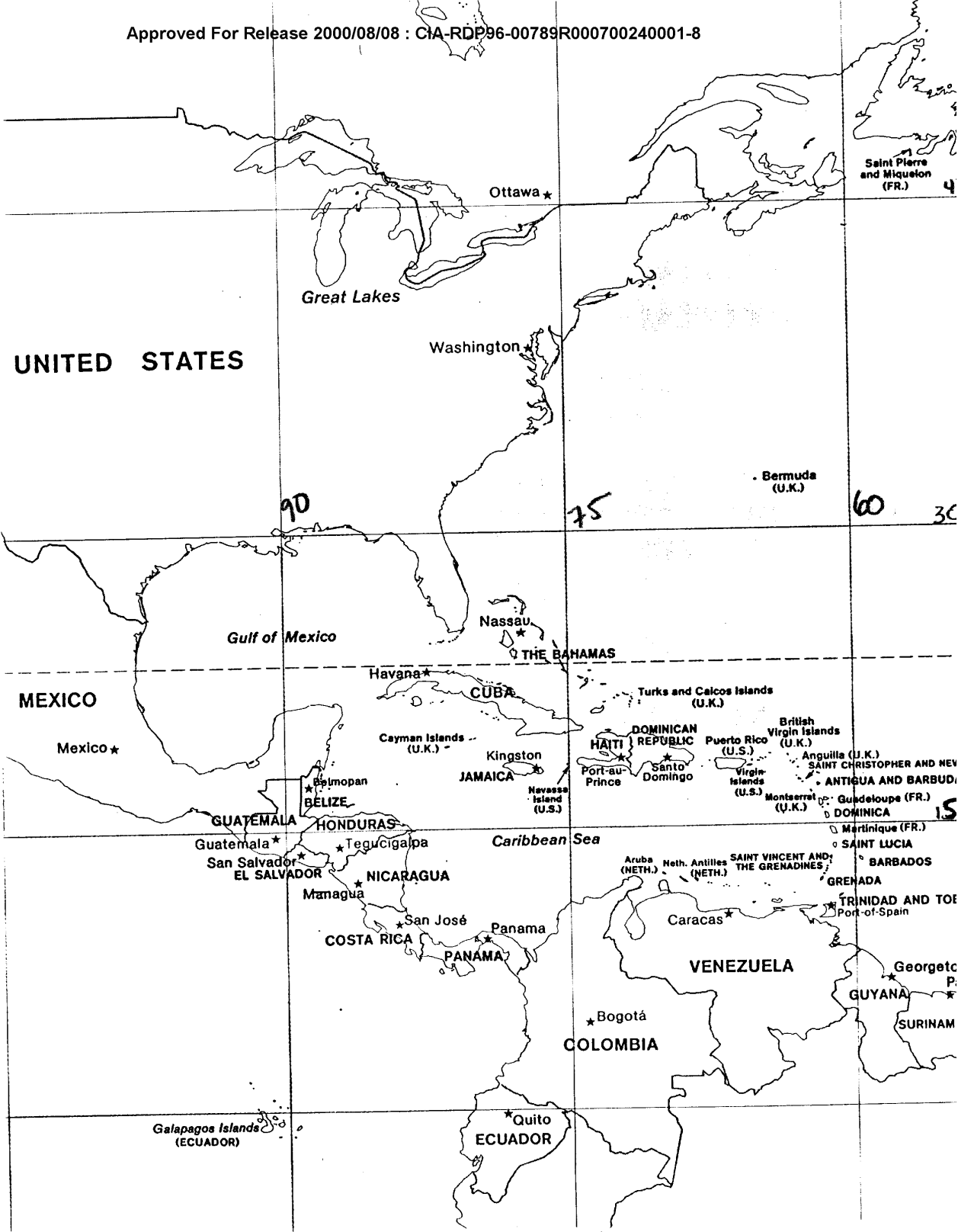
