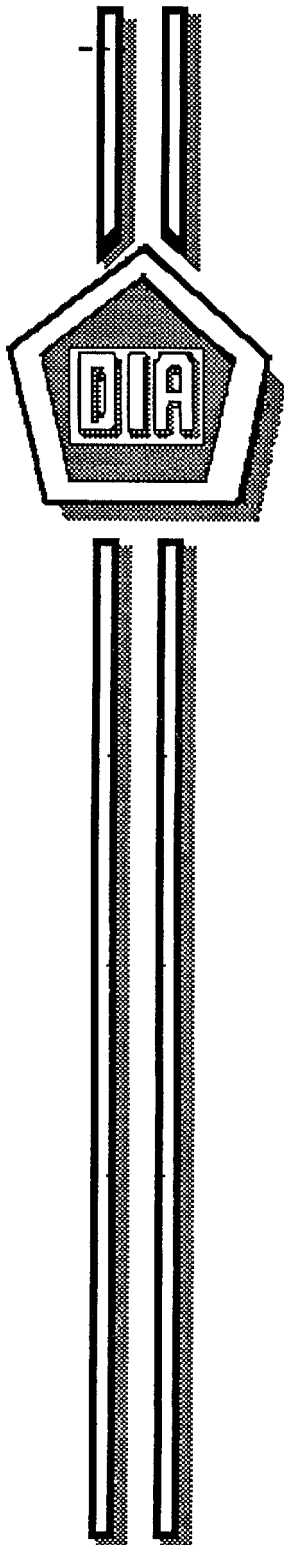

(U) PREFACE:

(S/NF/SG/LIMDIS) The Special Activity Report is part of on-going taskings in response to a request from Joint Task Force Five (JTF-5) in Alameda, California. The data provided in this report will be used by the J22 division in their assessment effort regarding their counterdrug mission. The information provided in this report was generated by PAG-TA employing remote viewing (RV) methodologies.

(S/NF/SG/LIMDIS) ^{SG1B} The data provided in this report concentrated on [REDACTED]. The results were forwarded to JTF-5 by secure fax on 3 August 1994. The JTF-5 evaluation feedback is at Appendix B.

(S/NF/SG/LIMDIS) The methodology used in this activity is exploratory. DATA SUMMARIES

(S/NF/SG/LIMDIS) Following are the perceived highlights from each source.

- (S/NF/SG/LIMDIS) ^{SG1B} Source A:

-- The target [REDACTED] is dealing wherein something this individual is doing may manifest between August and November of this year. He has been known in the past to have certain relationships but was hung up or delayed in receiving paid dues for his services. He may have been temporarily out of commission. He has been known to be involved with vessels and perhaps drugs.

- (S/NF/SG/LIMDIS) Source B:

-- No input.

- (S/NF/SG/LIMDIS) Source C:

-- Target is a personality who has a rather small build. He has dark hair and dark eyes. Personality is a drug runner and has been doing this for sometime. Personality is in the United States with connections to the East. Target personality is middle-aged. He lives alone. He knows exactly what he is doing and it is difficult for law enforcement agencies to get him. He may know street gangs.
