## SUMMARY

Higgins is in an oversized, type skiff that was towed to the point on the map indicated as "C-7". Other craft in the area of "C-7" are present to monitor and alert the captors of impending danger. Radio contact is being maintained with a radio station located between "Abalat" and "Ayntrar"; <sup>(H-4 1/2)</sup> Israeli Defense Forces (IDF) have the capability of conducting a voice, radio intercept against that position (Point between Abalat and Ayntrar).

Israeli reconnaissance would emanate an area located in the immediate vicinity of "Nahanya." <sup>(B-12)</sup> Higgins will be transferred from the oversized skiff to a motor boat that will attempt to reach Beirut. Water passage ways should be monitored to detect "an abnormal activity (by a boat) <sup>(v)</sup> attempting to gain access top Beirut at an abnormal time (evening hours?). The captors will feel the pressure of a "closing in" upon them. They will not be able to reach Beirut; they will land somewhere south of Beirut. They will release Higgins in the near future (by the end of May) and make believe that they have done so deliberately, when in fact short of killing him (which they are not allowed to do) they feel the pressure of pursuit and interception. The presence of excessive heat (fire) is associated with the time frame surrounding the release of Higgins.
