1. (S/NF/SK) MISSION: The following is a continuance of Viewer 095's training. This session has a twofold purpose: Determine Viewer's ability to work in the past, current and future during the course of one session; and to determine if a search can be successfully conducted in an ERV mode. Project 8808 deals with USMC LTC Higgins. Tasking via encrypted coordinates dealt with the location of LTC Higgins on 2 June 1988.
2. (S/NF/SK) VIEWER TASKING: From Encrypted Coordinates 561191/517240 and from clear acetate representing a geographical location determine the location of the individual of intelligence interest.
3. (S/NF/SK) COMMENTS: No inclemencies noted. CRV conference room was utilized. 095 sat in a chair, relaxed in accordance with ERV methodology and dowsed the rectangular piece of acetate in accordance with tasking reflected in Para 2. Viewer 095 dowsed for locations on 2 June 1988, 6 June 1988, and 8 June 1988. Summary is attached.

SUMMARY

On 2 June 1988 the results of plotting on the rectangular acetate revealed that the target person was located at Grid Location E +1/4 - 8, an area located on or near a river and in the immediate vicinity of "Dahr Dayr Manas". This location is situated northwest of "Az Zrarryah". (Az Zrarryah was the most prominent area in the vicinity of the target location.

The results of search for 6 June 1988 indicated a Grid Location of F - 1 plus 3/4, a point located in the 6 miles west of Beirut on the Mediterranean Sea.

The results of search for 8 June 1988 (two days in the future) identified a location at Grid Location E-3, located 8 miles west of Ba'l An Namah on the Mediterranean Sea.

At the end of the session, Viewer 095 indicated the presence of ongoing and target related activity at Grid Location of A-11, an area identified as ten miles west of the Lebanese/Israeli border on the Mediterranean Sea. The nature of the specific activity was not described by 095.

At location three, target was a somewhat boxy, old, white low (2-3 stories) structure with rough walls. It was on the edge of a road. To the right were other structures all sort of along the road which did to 90 degree turns. To the left there didn't appear to be any structures. The area was very dusty, dirty and dry and there was foliage in the areas away from the structures.
