SUMMARY OF INFORMATION

The target given as 4 April 1987, 1830 hours, refers to an unofficially sanctioned meeting of planners and organizers who devise and implement systems (plans) against "little countries" (third world areas) to achieve fiscal (financial), and political benefits. The activity is directed against "yellow band", "Indian" countries, not further described or identified. There are elements of secrecy surrounding the meeting and perceptions of "covert activity" in the sense of illegally and unofficially sanctioning the overthrow of a power base. A woman was present at the meeting; also, a man of Middle East origins. The meeting was sanctioned at the highest level and implemented with a provision for "plausibility for denial." The implementation of the activity was highly successful, financially and politically beneficial to its proponents.

The results of this plan of activity appeared in the newspapers.

An unidentified executive-type person (mainly responsible as a group leader), moved out of the country and was divorced from any ensuing activity related to the implementation of the plan.

The concept of high-ranking civilians implementing this plan via military managers and pathfinders appears germane to this entire target concept.

The names "Swatcho" and "Duncan" resurfaced phonetically as

being somehow associated with this meeting. (Alle Andria and Smoll surfaced phonetically during the course of the first session.)

Meetings continue to be held in the US as well as in other areas of the world. These ensuing meetings appear to be of secondary importance.

During the 4 April 1987 time period at 1800 hours, there were a group of men who were together holding an informal meeting. The men were middle-aged. They were planners and organizers. There was a woman involved in the meeting who was described as "not being too bright."

There was some type of accomplishment that took place during this time frame. There were systems involved and systems were accomplished.

There was a sweeping motion and something was dirty, rusty, and moldy.

Before this date, people were advised of the system. There was decision making at the highest levels. The highest decision made was by a civilian executive but the decisions filter down to military levels.

The executive is currently now persona grada. He has moved out of state. He will never be called back into the system.

The word "path finders" phonetically surfaced.

There was a backfiring effect and it could be read about in the newspapers.

The men devised a system and it worked.

The men were concerned about third world countries and

The meeting could have dealt with an overthrow of a government and the men speculated and took a gamble and won.

There are currently meetings at this site.

The feelings during the session were that of the U.S. and some type of spiritual feeling.
