The names of "Edward/Childs/Showers" surfaced phonetically as possible aliases utilized by the target personality.

HE is currently located "near water in the warehouse district" of a suburban area identified as "Dent," Ohio. More specifically, he is located at "Tippulo Street (phonetic) where Willow Boulevard crosses it at an area identified as "the 4400 block (of Tippulo)." He resides is some sort of "cardboard box." (OPS CMT: There is a Dent, Ohio, located about 5 to 10 miles northwest of Cincinnati, Ohio.)
