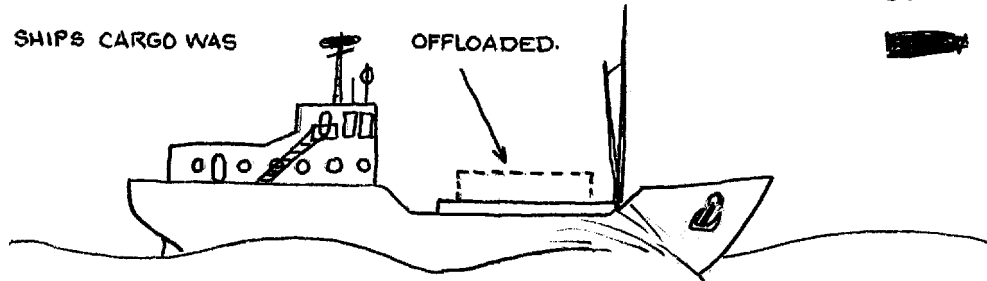

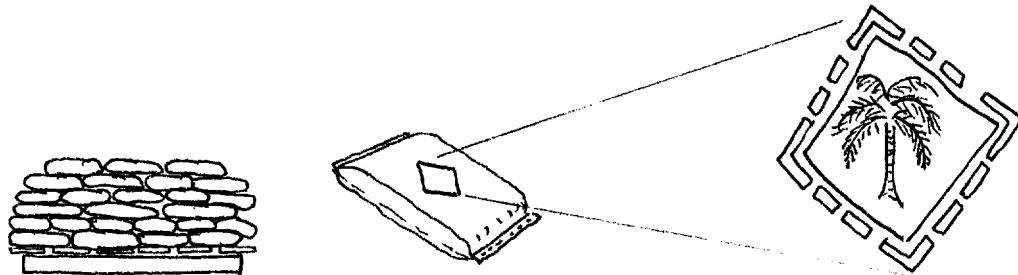

THESE BAGS HAD A DIAMOND-SHAPED LABEL WITH A PALM LEAF, OR PALM TREE IN IT.
THIS CARGO WAS OFF-LOADED VERY MUCH IN THE OPEN. I COULD NOT DETERMINE IF
THERE MIGHT HAVE BEEN SOMETHING CONCEALED INSIDE THE BAGS.
