-- OOE reported the aircraft would perform an airdrop near Puerto Rico (approx. 1823N 6513W) during the night of 3-4 JUL 90.

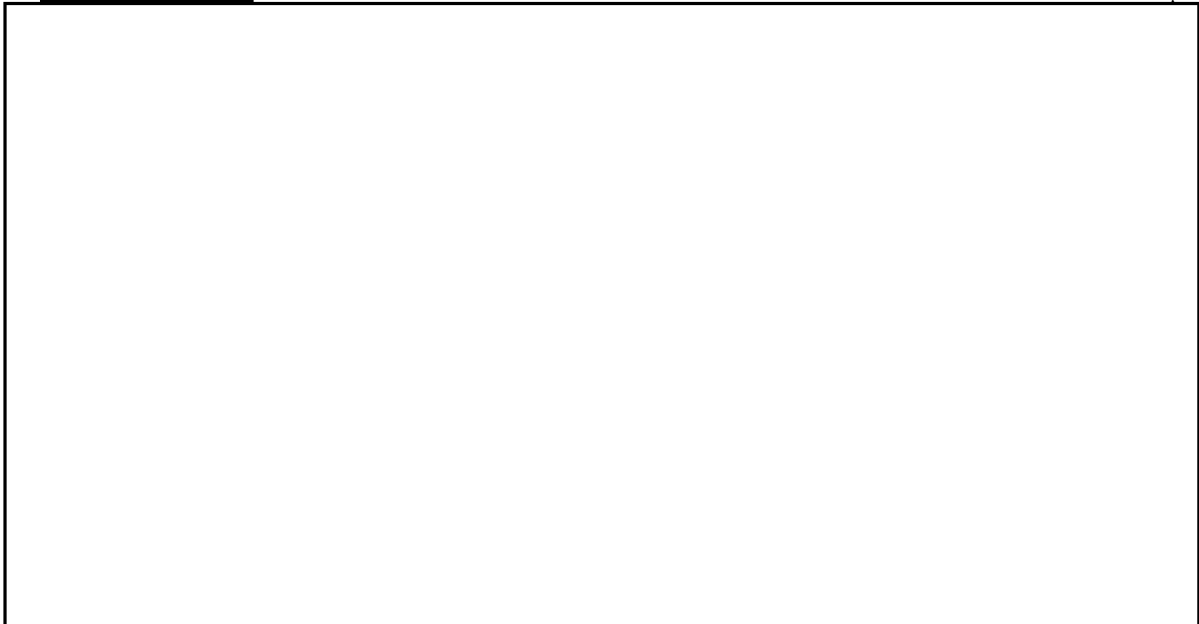
