DURING TODAY'S SESSION, I FELT THAT I WAS AT THE BEGINNING OF THE EVENT. IT SEEMED THAT THE GROUP ASSOCIATED WITH THE RED AND WHITE FLAG FIRED OR LAUNCHED A POINTED OBJECT INTO THE OTHER GROUP'S AREA. THIS OBJECT FLEW AND HIT THE EXACT AREA WHERE IT WAS SUPPOSED TO GO. THE GROUP THAT LAUNCHED THIS OBJECT WERE AT THE SIDE AND THEY COULD SEE WHERE THE OBJECT WAS GOING. THEY COULD WATCH THE WHOLE EFFECT. THE GROUP THAT WAS HIT WAS CAUGHT OFF GUARD. IT SEEMED THAT THE GROUP THAT WAS HIT WAS IN AND AROUND AN AREA. IN OTHER WORDS, THEY WERE NOT ALL TOGETHER. THEY TRIED TO GET OUT.
