1. Research Into Paranormal Ability to Break Through Spatial Barriers

This experiment used strict scientific procedures, one of a kind test samples, videotape and high speed photography to demonstrate the objective existence of the paranormal ability of breaking through spatial barriers. It also shows the physical process of this ability. It demonstrates that through the function of the paranormal ability, the macrobody was able to pass through the wall of a container and be removed, but no visible damage to the wall of the container was detected."

Conclusions of the experiment:

1. The paranormal ability to break through spatial barriers actually exists.
2. The break through point cannot be a hole in the container, a slit in the container or the edges of the seal, but is directly through the wall of the container.
3. The targets passed through the walls of the containers at different speeds, the average speed being 2.8 meters/second - slow enough to be adequately captured by high speed cameras or slow motion video cameras.
4. In the process of the experiments the walls of the containers have to have a slit, small hole or stopper for the experiment to succeed. However, in these experiments we discovered that the points at which the objects pass through the spatial barrier is not at the slit, the hole, or between the wall and the stopper, but is in the wall of the container.

2. A second experiment, similar to #1 above, was conducted by Wu Banghui (affiliation unknown). The essence of his experiment was to prove that matter can exist in abnormal states.

His conclusions were

(a) Certain objects, when acted upon by persons ~~with~~ with paranormal abilities, can be put into an abnormal state different from the normal states of matter.

(b) It is possible to switch back and forth from normal to abnormal states.

(c) Because no object has yet been found which can remain in a paranormal state for a long period of time after the functions have been eliminated, it may be believed being "under the influence of paranormal functions" is a condition of the existence of a paranormal state. In the terminology of physics, "the paranormal state" may be a strong coupling state between the somatic paranormal and material state.

Note: experiments 1 & 2 were repeated many times under apparently strict lab. conditions

Sun Shu-Su (Beijing Normal College) and

Sun Mo-Sheng (Beijing Iron and Steel Research Institute)

~~were~~ reported on experiments conducted using psychic powers to break needles and make them whole again in April 1981.

The major conclusions reached:

1. An electron ~~microscope~~ scanning microscope was used to analyze the break in the needle broken with psychic powers. The results of the analysis shows that the test object was pulled apart and not bent until broken. (May 81)

2. An electron scanning microscope was used to examine a needle that had been reformed with psychic powers. The results show that there is only the normal seam lines, and no sign of any welding. This is almost impossible to do using common methods.

"We feel the ability to break and reform needles is a psychic ability which objectively exists, and that further research into this ability, especially into the process of the super-precision reforming, could have major theoretical and practical implications."
