SUBJECT: SBI-REINVESTIGATION PROGRAM (SBI-PR) (ROXAD 94-84)
REFERENCE: OUR MSG 221353Z OCT 84, ROXAD 83-84

1. ROXAD 83-84 IS HEREBY RESCINDED.
 2. DURING OUR INSPECTION VISITS, WE NOTICED THAT AN ALARMING NUMBER OF SCI-INDOCTRINATED INDIVIDUALS HAVE SBIS OVER 4 1/2 YEARS OLD. REQUEST SBI-PRS BE INITATED FOR THESE INDIVIDUALS AS SOON AS POSSIBLE.
 3. WE HAVE RECEIVED NUMEROUS QUERIES CONCERNING THE VALIDITY OF THE INTERIM SBI-PRS CONDUCTED DURING THE MORATORIUM. THESE SBI-PRS MEET THE INVESTIGATIVE REQUIREMENTS OF DOD 5200.2-R/AFR 205-32, HOWEVER, SUBJECTS OF THESE INTERIM SBI-PRS DO NOT MEET SCI PERSONNEL SECURITY STANDARDS. BASED ON THE REASONS LISTED BELOW, FULL SCOPE SBI-PRS ARE NECESSARY AND REQUIRED.
 - A. A LARGE NUMBER OF SCI-INDOCTRINATED INDIVIDUALS WITH INTERIM SBI-PRS ARE BEING DENIED ACCESS TO SPECIAL PROJECTS AND SENSITIVE PROGRAMS BY COMMUNITY AGENCIES BECAUSE THESE AGENCIES WILL NOT ACCEPT THE INTERIM SBI-PRS. THIS HAS CAUSED A GREAT DEAL OF CONFUSION AND EMBARRASSMENT FOR OUR OFFICE AND THE INDIVIDUALS INVOLVED WHEN DEALING WITH OTHER AGENCIES IN THE INTELLIGENCE COMMUNITY.
 - B. THE INTERIM SBI-PR CONSISTED ONLY OF A LOCAL RECORDS CHECK, UP-DATED DD FORM 398, AND PERSONAL SCREENING INTERVIEW. THE FULL SCOPE SBI-PRS ARE PROVIDING SIGNIFICANT AMOUNTS OF UNFAVORABLE INFORMATION AS A RESULT OF THE PERSONAL INTERVIEWS CONDUCTED BY DIS AGENTS.
 4. THEREFORE, REQUEST THE INITIATION OF FULL SCOPE SBI-PRS FOR THOSE SCI-INDOCTRINATED INDIVIDUALS WITH SBIS 4 1/2 YEARS OLD AND THOSE WITH INTERIM SBI-PRS.
 5. THIS MESSAGE HAS BEEN COORDINATED WITH HQ AFOSP/SPIA AND SHOULD BE MADE AVAILABLE TO LOCAL AUTHORIZED REQUESTERS OF INVESTIGATIONS.
