SUBJECT: NSDD-71: US Policy Toward Latin America in the  
Wake of the Falklands Crisis (S)

(TS) National Security Decision Directive 71 (NSDD-71) details specific steps we will take to restore and reassert United States influence in Latin America to include increasing US military influence. The Department of Defense, in cooperation with the Department of State and Director of Central Intelligence, is to develop a prioritized list of defense requirements, by country, and an implementation strategy.

(C) I have appointed my DASD/IA, Nestor Sanchez, extension 697-5884, as head of the DOD effort. Please designate an appropriate official to represent your office to assist in developing a coordinated response to the NSDD-71 tasking. An initial meeting has been tentatively scheduled for 25 January 1983.
