3. RNSFLUNT in November cut the section subsidies in half and will do so again in December, thereby xxxixx creating a "pool" of 1,600 DM from subsidy funds already in hand. He asked permission to allot this to the local sections for January use - thereby keeping them in existence through January instead of forcing them to close down on December 31. I did not immediately agree to this, but told him that I thought it could be done provided that there appeared to be a fair chance of the Gesellschaft finding a sponsor by the time we meet again on December 10th. In any case, if the sections are kept intact for the month of January, there will be no additional cost to us. The organization's publication "Wehrkunde" will cease in December; all other paid-for activities will also stop by 31 December. Present membership size:
