1. UTILITY WAS TOLD DURING MEET 17 MAY THAT

WE COULD NOT UNDERTAKE HOFMANN COVERAGE. UTILITY WAS NEGATIVE TO
SUGGESTION UPHILL MAKE DIRECT REQUEST TO SMOOTHERS BECAUSE LETTERS
CLOSE RELATIONS CAVATA. HE SAID HE WOULD CONSIDER TRYING WORK
SOMETHING OUT WITH GLOBKE AND SCHROEDER.

2. CLEMENS COVERAGE NOT DISCUSSED WITH UTILITY BUT ALIAS
FLEMING PREFERS WE HANDLE. NO OBJECTION IF WE TELL SMOOTHERS

WE REQUESTING COVERAGE WITH UPHILL APPROVAL AND HANDLE AS FOLLOWS:

A. USE STORY THAT CLEMENTS PLAYS ROLE JOINT KUBARK/UPHILL
OP THAT HAS TAKEN ON CE OVERTONES AND OF CONSIDERABLE INTEREST

B. STATE MATTER SENSITIVE AND KNOWLEDGE WE REQUESTING COVERAGE WITH UPHILL BLESSING SHOULD BE TIGHTLY HELD. ATTEMPT GET TAPES INSTEAD TRANSCRIPTS FROM TAP. (COMMENT: UPHILL HOPES SMOOTHERS MAY TAKE EASY WAY OUT AND NOT MAKE TRANSCRIPTS FOR OWN ANALYSIS AND LEARN OF CLOSE CONTACT BETWEEN CLEMENS AND ALIAS FRIESEN. LATTER WELL KNOWN TO THEM AND WORKED FOR THEM PRIOR UPHILL EMPLOYMENT.)

C. MAKE POINT THAT IF SMOOTHERS FEEL NECESSARY QUERY UPHILL THIS MATTER, PLEASE HANDLE WITH UTILITY ONLY. (COMMENT: IF UPHILL BONN REPS QUERIED, MATTER WILL GET OUT OF CHANNELS AND PROBABLY BLOW FACT SERIOUS SECURITY INVESTIGATION UNDERWAY.)
