1. BASIS OUR EXPERIENCE WITH SMOOTHERS ON CALLIKAK BELIEVE

MOST UNLIKELY THEY WILL GRANT REQUEST BASIS STORY PARA 2 REF BECAUSE:

A. JUSTIFICATION MUCH TOO VAGUE AND LACKING IN DETAIL.

BECAUSE OF SENSITIVITY AND COST OF OPERATION SMOOTHERS RESTRICT
COVERAGE TO MOST IMPORTANT CASES. THUS ALL REQUESTS ARE EXAMINED
IN DETAIL AND EACH REQUEST MUST BE APPROVED BY FOREIGN OFFICE
ELEMENT OF SMOOTHER EMBASSY.

B. INCONCEIVABLE SMOOTHERS WOULD INSTITUTE COVERAGE ON

UPHILLER BASIS KUBARK REQUEST WITHOUT DIRECT CHECK WITH UTILITY.

MOREOVER ANY COVERAGE BONN/COLOGNE REA (I. E. DIPLOMATIC ENCLAVE)

REQUIRES GERMAN APPROVAL WHICH SMOOTHERS SAY THEY WOULD NORMALLY

2. BELIEVE FACT KUBARK MAKING REQUEST BEHALF UPHILL WOULD SO STIMULATE SMOOTHER INTEREST THAT THEY WOULD DEMAND MORE DETAILS THAN IF REQUEST CAME DIRECTLY FROM UTILITY. IN ANY CASE FEEL ONCE COVERALS INSTITUTED WE CAN BE CERTAIN SMOOTHERS WILL ANALYZE ALL TAKE MOST THOROUGHLY AND THAT THIS WILL APPLY WHETHER REQUEST ORIGINATED BY KUBARK OR UPHILL. IF TRUE REASON FOR COVERAGE DISGUISED IN ORIGINAL REQUEST THERE ALWAYS POSSIBILITY SMOOTHERS WILL DETECT REASON BY EXAMINATION INTERCEPTS. THIS PARTICULARLY APPLICABLE IF COVERAGE PRODUCES CONCRETE INFORMATION PERTINENT TO INVESTIGATION. FURTHERMORE, IF INVESTIGATION PROVES SUCCESSFUL AND UJDROWSY EXPOSED REASON FOR COVERAGE WILL BECOME PERFECTLY CLEAR TO SMOOTHERS IF THEY HAD NOT PREVIOUSLY GUESSED IT.

3. FEEL CERTAIN IF SMOOTHERS WERE AWARE SUSPICIONS AGAINST UJDROWSY THEY WOULD IMMEDIATELY WITHDRAW ALL SUPPORT STNEOPHYE INVOLVING SMOOTHER REAL ESTATE. IF SMOOTHER REAL ESTATE IS USED IN STNEOPHYE AND IF AT SAME TIME COVERAGE OF CLEMENS INSTITUTED BASIS KUBARK REQUEST PROVES INSTRUMENTAL EXPOSURE UJDROWSY SMOOTHERS

4. VIEW ABOVE FEEL PREFERABLE FROM KUBARK VIEWPOINT UTILITY
ARRANGE COVERAGE DIRECTLY WITH SMOOTHERS OR THROUGH GLOBKE AND

SCHROEDER. IN LATTER CASE ARRANGEMENT COULD ENCOMPASS BOTH

HOFMANN AND CLEMENS. INCLUSION UPHILLER WOULD SEEM STRENGTHEN

UTILITY'S HAND WITH GLOBKE AND CERTAINLY WITH SCHROEDER.
