1. PLEASE QUERY ALIAS BERNHARDT OR ALIAS FLEMING AS TO WHAT, IF ANY, ACTION UPHILL HAS INITIATED ON UJDRUMS TWO APARTMENTS IN COLOGNE. WE NOTE THE EXISTENCE OF THESE TWO APARTMENTS WAS MENTIONED TO YOU BY ALIAS FLEMING ON 7 JUNE 1961 WITH THE STATEMENT UPHILL WAS CHECKING OUT THE POSSIBILITY OF BUGGING AT LEAST ONE OF THEM. AS OF 3 AUGUST 1961 WE HAVE HAD NO FURTHER WORD ON THE SUBJECT AND FEAR UPHILL MAY EITHER BE DRAGGING THEIR FEET OR ATTEMPTING TO CUT US OUT OF THIS PHASE OF THE OPERATION.

2. WE FULLY REALIZE UPHILL'S PROBLEM IN FINDING APPROPRIATE PERSONNEL FOR SUCH AN UNDERTAKING BUT BELIEVE ACTION AGAINST THESE APARTMENTS SHOULD NOT BE DELAYED MUCH LONGER. SHOULD YOU LEARN THAT UPHILL'S DELAY HAS BEEN DUE TO PERSONNEL PROBLEMS, PLEASE INFORM THEM THAT KUBARK IS WILLING TO UNDERTAKE THE NECESSARY CASING OF THE APARTMENTS AND, IF FEASIBLE, SUBSEQUENT BUGGING.

3. WE AGREE WITH UPHILL THAT COLOGNE PRESENTLY APPEARS AS THE FOCAL POINT OF THE UJDROWSY, UJDRUM, UJDRUG COMPLEX. ALTHOUGH WE ARE STILL PREPARED TO COVER UJDROWSY'S OBERAUDORF RESIDENCE WITH THE APERIODIC RECEIVER AND, PENDING HEADQUARTERS DECISION, WITH AN ILLEGAL ENTRY, WE BELIEVE THE APARTMENTS IN COLOGNE OFFER A GREATER POSSIBILITY OF PRODUCING SIGNIFICANT EVIDENCE.
