DUTIES AT THE SOVIET CONSULATE. YOU WILL NOTE ONE PHOTOGRAPH INCLUDES A WOMAN IDENTIFIED BY AS KOROTKOV'S WIFE. IT WAS TAKEN IN DECEMBER 1958 IN COLOMBO, CEYLON. /AELADLE, HOWEVER, COULD NOT POSITIVELY IDENTIFY HER AS SUBJECT'S WIFE.

- 3. AELADLE REPORTED THAT SOME TIME AFTER THE VIENNA TOUR, KOROTKOV WAS STATIONED IN EAST GERMANY, PROBABLY DURING THE PERIOD 1956-1958 AND HAY HAVE WORKED IN COUNTERINTELLIGENCE IN GERMANY. HEADQUARTERS FILES SHOW THAT KOROTKOV MADE A TRIP TO VIENNA ON 4 SEPTEMBER 1957, USING A PASSPORT ISSUED ON 18 AUGUST 1957, AND RETURNED TO THE USSR ON 17 SEPTEMBER 1957. THE 4 JULY 1958 DATE MENTIONED IN PARAGRAPH 1 ABOVE WAS THE DATE HE LEFT FOR MOSCOW./
- 4. WHEN AELADLE LAST SAW KOROTKOV IN JUNE OR JULY 1960, KOROTKOV WAS ONE OF THE TWO OFFICERS IN THE MOSCOW KGB HEADQUARTERS RESPONSIBLE FOR HANDLING THE WORK OF THE SOVIET 'APPARAT'! IN GERMANY CONCERNED WITH CASES OF SOVIET AGENTS IN WEST GERMAN INTELLIGENCE ORGANIZATIONS. HIS RANK WAS PROBABLY THAT OF CAPTAIN. HE WAS A MEMBER OF THE COUNTERINTELLIGENCE DEPARTMENT OF THE KGB FIRST CHIEF DIRECTORATE / FOREIGN DIRECTORATE/. IN EXPLAINING THE JURISDICTION OF THE CI DEPARTMENT'S SECTION TARGETED AGAINST WEST GERMANY, AELADLE SAID THAT IF AN AGENT IS A CI DEPARTMENT AGENT, NO MATTER WHERE HE LIVES OR WHAT HIS NATIONALITY, HIS FILE IS HELD BY THE APPROPRIATE AREA DESK IN THE CI DEPARTMENT. THUS, A CASE INVOLVING AN AGENT RUN BY THE CI DEPARTMENT TARGETED AGAINST THE WEST GERMAN INTELLIGENCE SERVICE DOES NOT HAVE TO BE COORDINATED WITH THE AUSTROLGERMAN DEPARTMENT OF THE 1ST CHIEF DIRECTORATE EVEN IF THE AGENT IS A GERMAN NATIONAL.
- 5. THE ABOVE INFORMATION WAS FURNISHED BY THE REDWOOD DIVISION FROM ITS CURRENT DEBRIEFING OF AELADLE AND CAUTIONS THAT THE INFORMATION IS UNEVELUATED AND DOES NOT NECESSARILY REPRESENT ALL OF AELADLE'S KNOWLEDGE ON THE MATTER. THE INFORMATION IN PARAGRAPHS 2 THROUGH 4 IS LIMITED TO NO FOREIGN DISTRIBUTION.
