Sirs:

In order to achieve the degree of security which the activities of the Central Intelligence Group require, the Department will hereafter classify all such communications CONFIDENTIAL or higher.

Accordingly, all communications received, originating or transmitted over State Department communication facilities, which refer directly or indirectly to the procurement, location, relief from duty, promotion, names, operations, movement, pay, and other matters concerning Central Intelligence Group personnel and activities, as well as movement of equipment and supplies, should be classified CONFIDENTIAL or higher and should not be mentioned in plain text, UNCLASSIFIED or RESTRICTED communications.

SAFEGUARDING INFORMATION IN COMMUNICATIONS

WHICH REFER TO CENTRAL INTELLIGENCE

GROUP ACTIVITIES

I By an agreement with the Director of Central Intelligence to provide security protection to communications which refer to Central Intelligence Group activities, the Department will classify all such communications ~~CONFIDENTIAL~~ or higher. The Foreign Service has been advised of this requirement through a Serial Instruction.

II Accordingly, all messages received, originating or transmitted over State Department communication facilities, which refer directly or indirectly to the procurement, location, relief from duty, promotion, names, operations, movement, pay, and other matters concerning Central Intelligence Group personnel and activities, as well as movement of equipment and supplies, will be classified ~~CONFIDENTIAL~~ or higher and will not be mentioned in plain text, UNCLASSIFIED or RESTRICTED communications.
