a. Noted that Mr. Harrison of the Joint Committee on Printing had done an excellent job for us and would submit his full report in the very near future.

d. Referred to Senator Lyndon Johnson's letter concerning the personnel pool and stated he would have a reply today. In this connection, Mr. Hedden stated that the pool was in good shape and that Senator Johnson should be invited to send an accredited representative from his office to inspect the pool "unannounced".
