 ALSO KNOWN AS LE NGOC MINH, LEADING CADRE OF THE MILI-

 REGION 5, WHO WAS CAPTURED NEAR DANANG ON 5 JANUARY 69,
 AND WHO WAS CONVERTED TO HALLPER STATUS IN JULY 71.

 WHILE CAN APPEARED TO HAVE ABOVE AVERAGE INTELLIGENCE
 AND WAS COOPERATIVE DURING THE DEBRIEFING, HIS REPORTING
 RELIABILITY HAS NOT BEEN ESTABLISHED. HE OBTAINED THE
 INFORMATION IN PARAGRAPHS 1, 2 AND 5 FROM PERSONEL OBSER-

VATION, THE INFORMATION IN PARA 3 FROM A REPORT SUBMITTED BY THE KONTUM PROVINCE MILITARY PROSELYTING SECTION, AND THE INFORMATION IN PARA 4 FROM (FNU) THANH, A CADRE OF THE QUANG DA PROVINCE MILITARY PROSELYTING SECTION.

~~WAS~~ ~~IN~~ ~~THE~~ ~~QUANG~~ ~~NAM~~ PROVINCE UNIT IN LAI THANH HAMLET, HOA LUONG VILLAGE, HOA VANG DISTRICT, AND TURNED OVER TO THE MILITARY PROSELYTING SECTION OF QUANG NAM PROVINCE. AS DEPUTY CHIEF OF THE SECTION IN CHARGE OF PRISONERS OF WAR, MAJOR LE CAN DECIDED TO RELEASE THE PRISONERS BECAUSE THERE WAS NO ADEQUATE DETENTION CAMP NEARBY AND TO TAKE THEM TO THE MILITARY PROSELYTING SECTION OF MILITARY INTER-REGION WOULD TAKE BETWEEN TWO AND THREE MONTHS. (FIELD COMMENT: VIET CONG MILITARY INTER-REGION 5 INCLUDED GOVERNMENT OF VIETNAM (GVN) QUANG NAM, QUANG TIN, QUANG NGAI, BINH DINH, PHU BON, KONTUM AND AR LAC PROVINCES.)

2. ONE OF THE PRISONERS RELEASED WAS CALLED BROWN AND HELD THE RANK OF EITHER PRIVATE FIRST CLASS OR SERGEANT; HE WAS AN ADVISOR TO THE GVN REGIONAL FORCES COMPANY IN HOA VANG DISTRICT. HE WAS BETWEEN 19 AND 26 YEARS OF AGE, ABOUT 1.80 METERS TALL, AND WEIGHED ABOUT 75 KILOGRAMS; HE HAD GREY EYES, BLOND HAIR, A LARGE FOREHEAD, STRAIGHT NOSE AND PALE COMPLEXION. THE OTHER PRISONER WAS CALLED KIM (PHONETIC), AND HELD THE SAME RANK AND POSITION AS THE OTHER PRISONER. HE WAS ABOUT THE SAME AGE AS BROWN AND WAS ABOUT 1.80 METERS TALL AND WEIGHTED ABOUT 85 KILOGRAMS. (HE ALSO HAD BLOND HAIR, GRAY EYES, A STRAIGHT NOSE BUT HAD A TANNED COMPLEXION.)

3. CAN SAW A REPORT SUBMITTED BY THE KONTUM PROVINCE MILITARY PROSELYTING SECTION CONCERNING THE CAPTURE OF

AMERICAN MEDICAL OFFICER WHO HELD THE RANK OF CAPTAIN.
(FIELD COMMENT: THIS PRISONER MAY BE IDENTICAL WITH CAPTAIN
EDYD KUSHNER WHO WAS REPORTED TO BE IN QUANG NGAI PROVINCE IN
DECEMBER 1970 AND WAS A CAPTAIN AND A MEDICAL DOCTOR.) KUSHNER
MADE SEVERAL RADIO BROADCASTS FOR THE VC. THE PRISONER WAS
TURNED OVER TO THE MILITARY PROSELYTING SECTION OF MILITARY
INTER-REGION 5 WHICH PUT HIM INTO A DETENTION CAMP WHERE HE
LATER CONTRACTED DYSENTERY AND DIED. HE WAS BURIED IN TRA MI
DISTRICT, QUANG NAM PROVINCE, BUT THE EXACT LOCATION WAS NOT
KNOWN. HE WAS ABOUT 40 YEARS OLD.

4. [REDACTED] CAN WAS ON A TRIP TO DIEN TIEN VIL-
LAGE, DIEN BAN DISTRICT, QUANG NAM PROVINCE, WHERE HE MET (FNU)
H'A N H, A CADRE OF THE MILITARY PROSELYTING SECTION OF QUANG
DA PROVINCE. THANH TOLD HIM THAT AN AMERICAN PRISONER OF WAR
HAD BEEN RELEASED IN 1966 BUT HAD REFUSED TO RETURN TO HIS
UNIT. THE AMERICAN INSTEAD HAD VOLUNTEERED TO WORK AS A PROPAG-
ANDA CADRE FOR THE MILITARY PROSELYTING SECTION OF MILITARY
INTER-REGION 5. CAN WAS NOT CERTAIN BUT THOUGHT THE NAME OF
THE PRISONER WAS BOBBY. (FIELD COMMENT: THIS PRISONER MAY BE

CAPTURED BY THE VC IN 1965 WHO IS REPORTED TO HAVE DEFECTED IN
(1967.) ACCORDING TO THANH THE PRISONER WAS A PRIVATE FIRST
CLASS. AFTER HE DEFECTED, HE USED A LOUDSPEAKER TO BROADCAST
COMMUNIST PROPAGANDA TO THE U.S. 5TH MARINE REGIMENT, LOCATED
AT [REDACTED] NO MILITARY NAME, DIEN TIEN VILLAGE, DIEN BAN DISTRICT.
PRIOR TO 1964, THERE WAS NO CLEAR POLICY ON THE DISPOSAL
OF BODIES OF DEAD AMERICAN PRISONERS. USUALLY, THEY WERE
LEFT BY THEIR CAPTORS WHERE THEY DIED. IN 1964, THE CENTRAL
COMMITTEE FOR SOUTH VIETNAM ISSUED A DIRECTIVE, NUMBER NOT KNOWN,

WHICH OFFICIALLY ORDERED THE PRISONERS BURIED WHERE THEY DIED; THE CAPTURING UNITS, HOWEVER, WERE INSTRUCTED TO PREPARE A SKETCH OF THE EXACT LOCATION OF THE GRAVE. THIS SKETCH, PLUS ALL IDENTITY PAPERS AND PERSONAL BELONGINGS OF THE PRISONERS WERE SENT TO THE NEXT HIGHER UNIT, WHICH WOULD THEN FORWARD THEM TO THE MILITARY PROSELYTING SECTION OF MILITARY INTER-REGION 5. AS OF JANUARY 1969, THE MILITARY PROSELYTING SECTION CONSISTED OF COLONEL (FNU) T R I, CHIEF OF THE SECTION AND ALSO IN CHARGE OF PENETRATION ACTIVITIES; LIEUTENANT COLONEL (FNU) T H A I, DEPUTY CHIEF OF THE SECTION AND ALSO IN CHARGE OF PROPAGANDA ACTIVITIES; MAJOR (FNU) S A U, PENETRATION CADRE; MAJOR LE CAN, PENETRATION CADRE; MAJOR (FNU) KEY, PENETRATION CADRE; AND MAJOR (FNU) N I N H, ADMINISTRATIVE CADRE.

6. (FIELD COMMENT: ADDITIONAL BIOGRAPHIC INFORMATION ON

CAN -- HE WAS BORN IN NOVEMBER 1931 IN AN LAG HAMLET, MY HOA BLAISE, PHU MY DISTRICT, BINH DINH PROVINCE, SOUTH VIETNAM. JOINED THE VIET CONG IN 1950, BECAME A PROBATIONARY MEMBER OF THE PEOPLE'S REVOLUTIONARY PARTY THAT SAME YEAR, AND BECAME FULL PARTY MEMBER IN JULY 1951. HE REGROUPED TO NORTH VIETNAM IN 1953 AND IN MAY 1955 WAS ASSIGNED AS COMMANDER OF A RECONNAISSANCE COMPANY OF THE 324TH DIVISION. BETWEEN JULY 1957 AND EARLY 1960, HE RECEIVED TRAINING AT THE INFANTRY REFRESHER SCHOOL IN QUANG TAY PROVINCE. CAN INFILTRATED SOUTH VIETNAM IN 1960 AND WAS APPOINTED DEPUTY CHIEF OF THE MILITARY PROSELYTING SECTION OF QUANG NAM PROVINCE. IN EARLY 1966, HE WAS APPOINTED TO THE POSITION HE HELD AT THE TIME OF CAPTURE.)
