EXTRADITION OF RAMON <<<MATTA>> <<<BALLESTEROS>>, AN ALLEGED DRUG

TRAFFICKER.

A PRTC-H COMMUNIQUE MADE AVAILABLE TO DPA'S MANAGUA OFFICE

NOTES THAT <<<MATTA>> WAS "KIDNAPPED BY SPECIAL TROOPS ON ORDERS FROM

THE U.S. GOVERNMENT," WAS THEN TAKEN FROM TEGUCIGALPA TO THE

DOMINICAN REPUBLIC, AND FROM THERE BROUGHT TO THE UNITED STATES.

THE COMMUNIQUE NOTES THAT <<<MATTA>> WHO HAS BEEN ACCUSED BY THE

UNITED STATES OF DRUG TRAFFICKING, WAS "FACING LEGAL PROCEDURES" IN

HONDURAS. HIS KIDNAPPING "AS AN ALTERNATIVE TO HIS EXTRADITION"

REPRESENTS AN ACTION THAT "VIOLATES THE CONSTITUTION" OF HONDURAS.

THE PRTC-H BELIEVES THAT THIS ILLEGAL ACTION PROVOKED THE PROTESTS

IN "DEFENSE OF NATIONAL SOVEREIGNTY AND DIGNITY."
