(COMMUNIQUE ISSUED BY THE POLITICAL AND MILITARY LEADERSHIP
OF THE FMLN'S HARDOQUEO CRUZ URBAN GUERRILLA COMMAND -- DATE
AND PLACE NOT GIVEN)

(TEXT) TO THE SALVADOREAN AND CENTRAL AMERICAN PEOPLES, AS
WELL AS OTHER PEOPLES IN THE WORLD AND THE NATIONAL AND INTERNATIONAL
PRESS, WE REPORT:

1. OUR COMMANDOS HEREBY TAKE RESPONSIBILITY FOR THE EXECUTION
OF THE POLITICAL AND MILITARY OPERATION CALLED "AGGRESSOR YANKEE,
EL SALVADOR WAITS FOR YOU LIKE ANOTHER VIETNAM." THE
OPERATION CONSISTED OF THE ANNIHILATION OF U.S. MILITARY
ADVISERS, CIA AGENTS, AND MEMBERS OF OTHER NATIONALITIES LINKED
TO INTELLIGENCE ORGANIZATIONS IN THE SERVICE OF THE U.S.
IMPERIALISM. THESE PEOPLE WERE IN THE ZONA ROSA IN THE SAN
BENITO NEIGHBORHOOD, SPECIFICALLY AT THE LOS CHILES RESTAURANT.

2. IN VIEW OF THE DISTORTED VERSION OF THE FACTS DISSEMINATED
BY THE PUPPET GOVERNMENT AND ITS GENOCIDAL ARMED FORCES WITH THE
PURPOSE OF JUSTIFYING THEIR INCOMPETENCY AND IN AN EFFORT TO ALTER
THE TRUE NATURE OF THIS REVOLUTIONARY ACTION, WE HEREBY EXPLAIN
THE OPERATION. THE FIRE OF OUR REVOLUTIONARY RIFLES WAS
CONCENTRATED ONLY IN THOSE PLACES WHERE THE MILITARY ADVISERS AND
THEIR ASSOCIATES WERE LOCATED. DURING THE ANNIHILATION OPERATION,
AN EXCHANGE OF SHOTS OCCURRED BETWEEN OUR SHOCK FORCE GUERRILLAS AND
ARMED SECURITY MEMBERS IN CIVILIAN CLOTHES NEAR THE SITE OF THE
OPERATION. AS THE RESULT OF THIS, MANY PEOPLE IN NEARBY
ESTABLISHMENTS WERE CAUGHT IN AN INDISCRIMINATE CROSSFIRE.

ON BEHALF OF THE RESPONSIBILITY AND SERIOUSNESS THAT OUR PEOPLE
DESERVE, WE WANT TO MAKE CLEAR THAT OUR MEN DID NOT USE G-3
RIFLES, EITHER IN THIS CLASH OR THE ONE BETWEEN OUR SHOCK FORCES
AND ARMY SECURITY MEMBERS. WE REGRET THAT DUE TO THE LIMITED
FIGHTING ABILITY OF THESE ARMY MEN IN CIVILIAN CLOTHES, OUR PEOPLE
HAVE HAD TO PAY SUCH A HIGH PRICE IN HUMAN LIVES.

OUR COMMANDOS APPEAL TO THE VARIOUS SOCIAL SECTORS OF OUR PEOPLE
TO REFRAIN FROM VISITING THOSE PLACES VISITED BY ARMY MEN OF BOTH THE
PUPPET ARMY AND FOREIGN GOVERNMENTS ENGAGED IN REPRESSIVE AND
GENOCIDAL ACTIVITIES AGAINST THE REVOLUTIONARY PEOPLE'S MOVEMENT
BECAUSE THESE ARMED MEN HAVE BECOME MILITARY TARGETS AS OF THIS

MOVEMENT.

WE APPEAL TO THE U.S. PEOPLE TO REDOUBLE THEIR EFFORTS AND
OPPOSE RONALD REAGAN'S WARHONGERING ADMINISTRATION IN ORDER TO
PREVENT HIM FROM EMBARKING ON A MILITARY ADVENTURE THAT WOULD
ONLY CAUSE THE AMERICAN PEOPLE GREATER GRIEF AND SUFFERING.
FINALLY, WE REPORT THAT OUR UNITS WITHDREW WITHOUT ANY TROUBLE
AFTER THEY WERE (CHASED) BY THE ENEMY.

UNITED TO FIGHT TO THE FINAL VICTORY. REVOLUTION OR DEATH, WE
WILL WIN.
