1. PER TELECON KENNARD/ZANKA WAVE HAD PASSAVOY DISCUSS WITH AMBUD-

 A-1 TOLD PASSAVOY HE COLD ABOUT THIS MATTER BUT FELT IT IS IN THE BEST
 INTEREST TO ALL CONCERNED. A-1 ALSO FELT THAT FAMILIES OF CREW
 MEMBERS PROBABLY HAVE ALREADY GIVEN THEM UP FOR DEAD. IF THIS
 MATTER BROUGHT TO LIGHT AND FAMILIES INFORMED THEY WOULD WANT TO TRAV
 INQUIRE FURTHER, ETC. A-1 PREFERS LEAVING IT DORMANT IF THEY CAN BE
 BURIED IN NICARAGUA.

2. A-1 REQUESTED IDENTITIES OF CREW MEMBERS ASAP. HE SAID WOULD
 OWN ACTION GETTING WORD TO FAMILIES RE CONFIRMATION OF DEATH BUT WOULD
 NOT REVEAL REF.
