

GROUPS OF THE GUATEMALAN NATIONAL REVOLUTIONARY UNION (URNG) HAVE BEEN SUCCESSFUL IN PROMOTING A PALSE CLAIM THAT CLANDESTINE PRISONS EXIST IN GUATEMALA WHERE POLITICAL PRISONERS ARE ALLEGEDLY ILLEGALLY DETAINED BY THE ARMED FORCES.

"URNG APPROVED" FRONT GROUPS MASQUERADING AS HUMAN RIGHTS GROUPS, THE MUTUAL SUPPORT GROUP (GAM), THE COMMITTEE FOR CAMPESINO UNITY (CUC), PEACE BRIGADES (BRIGADES DE PAZ) AND THE UNITED GUATEMALAN OPPOSITION (RUCG) HAVE SUCCESSFULLY CONVINCED INTERNATIONALLY-BASED GROUPS SUCH AS "AMERICAS WATCH" THAT CLANDESTINE PRISONS EXIST IN GUATEMALA AND THAT THIS HAS BROUGHT ABOUT UNDESERVED CONDEMNATION OF THE GUATEMALAN GOVERNMENT.
