SUBJECT: Noel Haviland FIELD

1. Reference is made to your memorandum dated 24 January 1950, subject as above, wherein you forwarded a report from an informant of known reliability concerning the present whereabouts of subject, and wherein it was stated that the informant understood subject to be an American counter-intelligence agent who acted as paymaster to American intelligence agents operating behind the Iron Curtain. (c)

2. Please be advised that this Office has had no contact with subject; it does not employ him in any capacity and has not employed him in the past.

3. In view of the extreme importance of this case, it would be appreciated if you would endeavor to ascertain from your informant the basis for his "understanding" that subject had connections with an American intelligence service. Further details concerning the situation of informant's source and how source was able to obtain the report that subject is presently in Russia would also be appreciated if obtainable.
