



ON 9 DECEMBER 1992, GUATEMALAN COVERNMENT LEADERS LEARNED THAT THE EUROPEAN PARLIAMENT WAS PREPARING A DRAFT HUMAN RIGHTS RESOLUTION THAT PLACES GUATEMALA UNDER ITEM 12 APPLICABLE TO THE WORLD'S WORST HUMAN RIGHTS OFFENDERS. - ITEM 12 ALSO CALLS FOR THE ASSIGNMENT OF A HUMAN RIGHTS RAPPORTEUR FOR CUATEMALA.

COMMENT: ITEM 12 APPARENTLY REFERS TO ONE OF THE DECLARATIONS OF STATUS OF CERTAIN COUNTRIES THAT ARE DETERMINED AT THE ANNUAL UNITED NATIONS HUMAN RICHTS COMMISSION (UNHCR) HEETINGS IN GENEVA. DURING THE UNHRC HEETING IN EARLY 1992, THE EUROPEAN COMMUNITY (EC) — COUNTRIES INITIALLY SUPPORTED HOVING GUATEMALA FROM AGENDA ARTICLE 19 (ADVISORY SERVICES), REQUIRING ONLY THE APPOINTMENT OF A UN ADVISER/EXPERT ON HUMAN RICHTS, TO THE HORE ONEROUS AGENDA ITEM 12 (COUNTRY SPECIFIC), WHICH IS RESERVED FOR THE HOST SERIOUS VIOLATORS AND REQUIRES THE NAMING OF A SPECIAL RAPPORTEUR. THIS REPORTED DRAFT EUROPEAN PARLIAMENT RESOLUTION INDICATES THAT, AS IT HAS IN PAST YEARS, THE EC WILL GO TO THE NEXT UNHER HEETING IN EARLY 1993 WITH THE INTENTION OF PRESSING FOR A CHANGE IN GUATEMALA'S STATUS FROM ARTICLE 19 TO ARTICLE 12.)

OFFICIAL COMMENTED OF THE EUROPEAN DRAFT HUHAN RIGHTS RESOLUTION IS COMPLETELY UNACCEPTABLE TO THE COG AND THE GUATEMALAN HILITARY. THE COC HAS BEEN FIGHTING AGAINST THE PASSAGE OF SUCH AH ITEM FOR THE LAST FIVE YEARS POLITICAL INPLICATIONS OF ITEH 12 ARE THE MOST SIGNIFICANT. AS IT PUTS GUATEHALA IN THE CATEGORY OF SUCH COUNTRIES AS IPAQ. THE INTERNATIONAL COMMUNITY IS DIRECTING HUMAN RIGHTS POLICY TOWARD GUATEMALA IN SUCH A WAY THAT GUATEMALA EVENTUALLY WILL BE IN A SITUATION SIMILAR TO THAT OF EL SALVADOR, WITH A PERMANENT UN HUMAN RIGHTS PRESENCE. THE COG RECENTLY HAS COME UNDER INCREASED PRESSURE FROM THE INTERNATIONAL COMMUNITY FOR MORE INTERNATIONAL INVOLVEHENT IN THE PEACE NECOTIATIONS WITH THE GUATEMALAN GUERRILLAS. TO WHICH THE GOG IS STRONGLY OPPOSED. THE CURRENT VIEW AMONG SENIOR HILITARY AND GOG OFFICIALS IS TO CONTINUE COOPERATING WITH THE INTERNATIONAL COMMUNITY ON HUMAN RICHTS ISSUES BUT ONLY TO THE EXTENT THAT THEY ARE NOW, WITH NO FURTHER CONCESSIONS.





RECARDING ONE WELL-KNOWN HUMAN RIGHTS CASE, THE GUATEMALAN HILITARY HAS COHE UNDER INCREASED PRESSURE FROM THE UNITED STATES (U.S.) ON BEHALF OF THE BLAKE FAMILY WHOSE SON NICHOLAS ((BLAKE)), DA FREELANCE JOURNALIST, WAS HURDERED IN GUATEMALA ALONG WITH COLLEAGUE CRIFFEN ((DAVIS)) DIN 1985. THE BLAKE FAMILY CURRENTLY IS PREPARING TO PRESENT A CASE AGAINST GUATEMALA IN THE INTER-AMERICAN COURT IN AN ATTEMPT TO COLLECT FINANCIAL COMPENSATION FOR THE LENGTHY SEARCH FOR THEIR SON'S REMAINS AND FOR THE GRIEF SUFFERED BY FAMILY HEMBERS, SPECIFICALLY THE MOTHER WHO APPARENTLY HAS HEALTH PROBLEMS WHICH RESULTED FROM THIS INCIDENT.

THE U.S. SHOULD NOT EXPECT COC AUTHORITIES TO COLLABORATE ON THE INVESTIGATIONS OF PAST INCIDENTS IF THE GUATEHALANS HUST FEAR THEIR EFFORTS WILL BE USED AGAINST THEN IN A SUIT AGAINST THE COC.
