[REDACTED] COMMENT: [REDACTED] PRESS OF 5 NOVEMBER REPORTED THE ARREST OF LAURA A L L E N D E DE PASCAL, DAUGHTER OF FORMER PRESIDENT SALVADOR ALLENDE AND MOTHER OF ANDRES P A S C A L ALLENDE, NEW SECRETARY GENERAL OF THE MOVEMENT OF THE REVOLUTIONARY LEFT (MIR), UNDER CHARGES OF ILLEGAL POSSESSION OF ARMS AND INVOLVEMENT IN SUBVERSIVE ACTIVITIES. 2. ACCORDING TO [REDACTED], BOTH SHE AND HER LIVING COMPANION, BEATRIZ V A R G A S, ARE BEING HELD AT THE "TRES ALAMOS" DETENTION CENTER OUTSIDE OF SANTIAGO.

STATED, HOWEVER, THAT THEY HAD UNDERGONE EXTENSIVE VERBAL
INTERROGATION REGARDING THEIR MIR CONNECTIONS.

3. ACCORDING TO [REDACTED] ALLENDE WAS IN RELATIVELY
GOOD SPIRITS AND HER HEALTH WAS AS GOOD AS COULD BE EXPECTED,
GIVEN HER CHRONIC ILLNESS. ALLENDE SAID THAT SHE HAD TOLD HER
INTERROGATORS ALL SHE KNEW ABOUT THE ACTIVITIES OF HER SON,
ANDRES, BUT SHE FELT CONFIDENT THAT THE INFORMATION WOULD NOT
BE OF USE SINCE IT WAS NOT CURRENT AND SHE HAD HAD NO DIRECT
CONTACT WITH ANDRES FOR OVER A MONTH PRIOR TO HER ARREST.

4. [REDACTED], WHO SAID THAT HE HAS TALKED WITH ALLENDE ON SEVERAL
OCCASIONS, HAS BEEN WORKING TO GAIN HER RELEASE THROUGH THE
INFLUENCE OF HUGO L E O N, PRESIDENT OF THE INGAS
CONSTRUCTION FIRM. [REDACTED] AND A CLOSE COLLABORATOR
OF THE JUNTA GOVERNMENT. [REDACTED] SAID THAT TO DATE, HOWEVER, THERE
HAVE BEEN NO INDICATIONS FROM THE GOVERNMENT THAT ALLENDE WILL
