



THE CNI INVESTIGATIONS HAVE ALMOST BEEN

COMPLETED AND CNI SHOULD BE ABLE TO MAKE A PUBLIC DISCLOSURE OF ITS FIND IN 35 WITHIN ONE OR TWO WEEKS.

COMMENT: THERE IS STILL SOME SPECULATION HITHIN LEADERSHIP CIRCLES OF THE ARMY THAT CONTRERAS AND THE CNI ARE RESPONSIBLE FOR AT LEAST SOME OF THE BOMBINGS.
