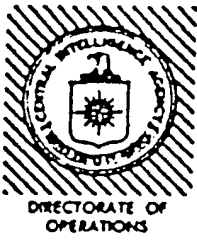

1. THE OPPOSITION POLITICAL PARTIES, THE VICARIATE OF SOLIDARITY AND RELATIVES OF THE DISAPPEARED PERSONS HAVE AGREED THAT NO PROVOCATIVE ACTIONS SUCH AS STREET DEMONSTRATIONS OR SIT-INS WILL BE CARRIED OUT DURING THE VISIT OF THE UNITED NATIONS HUMAN RIGHTS COMMISSION (UNHRC) WORKING GROUP SCHEDULED FOR 12 TO 26 JULY 1978. INSTEAD IT HAS BEEN AGREED THAT THESE GROUPS WILL COLLABORATE IN THE PREPARATION OF A SERIES OF REPORTS AND BRIEFINGS FOR PRESENTATION TO THE UNHRC WORKING GROUP WHICH WILL BE BASICALLY HUMANITARIAN RATHER THAN POLITICAL. VICARIATE OF SOLIDARITY HAS BEEN THE FOCAL POINT FOR THE PLANNING AND COORDINATION OF THIS EFFORT. THE POLITICAL PARTIES PARTICIPATING IN THIS EFFORT ARE THE COMMUNIST PARTY (PCCH), SOCIALIST PARTY (PSCH) AND THE CHRISTIAN DEMOCRATIC PARTY (PDC).

2. PRESENTATIONS FOR THE UNHRC WORKING GROUP ARE BEING PREPARED IN FOUR BASIC AREAS:

A. JURIDICAL: THE BULK OF THE PRESENTATIONS TO THE GROUP WILL BE MADE BY THE VICARATE OF SOLIDARITY'S COMMUNICATIONS DEPARTMENT AND WILL COVER THE AREAS OF DISAPPEARANCES, TORTURE, SECURITY SERVICES EXCESSES, LACK OF LEGAL GUARANTEES, AND THE TOTAL INEFFECTIVENESS OF THE CHILEAN JUDICIAL SYSTEM. A SUMMARY REPORT REVIEWING THE CASES OF ALL 616 DISAPPEARED WILL BE PRESENTED AS WELL AS DOSSIERS ON ALL THE MAJOR AREAS OF GROSS REPRESSION OVER THE PAST YEARS. THOSE RESPONSIBLE FOR THE PREPARATION OF THIS MATERIAL ARE ANDRES A Y L M I N (PDC), GUILLERMO C A C E R E S (PCCH), ENRIQUE S H E P E L E R, RADICAL PARTY (PR), AND SERGIO F E R N A N D E Z (PSCH).

B. LABOR: DISCUSSION OF THE LACK OF LABOR UNION FREEDOMS AND VIOLATIO OF WORKERS RIGHTS WILL BE TAKEN UP WITH THE WORKING GROUP BY LEADERS OF THE GROUP OF TEN AND THE LARGELY MARXIST NATIONAL TRADE UNION COORDINATING BODY. THESE LABOR ORGANIZATIONS HAVE BEEN PREPARING DOCUMENTS AND STUDIES TO SUBSTANTIATE THEIR POSITION WITH THE LEGAL ASSISTANCE OF JORGE D O N O S O (PDC), THE VICARIATE OF SOLIDARITY'S LABOR DEPART-

MENT, AND FROM VICARIATE LAWYERS ALEJANDRO G O N Z A L E Z (PDC) AND ORLANDO V E L A S Q U E Z (PCCH). THE LABOR GROUPS WILL ALSO ORGANIZE A SERIES OF PUBLIC FORA AT WHICH THE WORKING GROUP MEMBERS CAN DICUSS THE PROBLEMS OPENLY WITH GROUPS OF WORKERS.

C. YOUTH/STUDENTS: THESE PRESENTATIONS ARE BEING ORGANIZED WITHIN THE UNIVERSITY OF CHILE LAW SCHOOL, WITH GUILLERMO Y U N G E (PDC) AND SERGIO B O D A N O V I C (PSCH) AS SPOKESMEN, AND EDGARDO B O E N N I N G E R (PDC) AND MANUEL ANTONIO G A R R E T O N PROVIDING COUNSELING AND BACKGROUND ASSISTANCE. THIS FRONT WILL SEEK AN INTERVIEW WITH THE WORKING GROUP TO DISCUSS THE LACK OF CULTURAL AND EDUCATIONAL FREEDOMS IN CHILE, CONTROL OF ACADEMIC PROGRAMS AND HARRASSMENT OF PROFESSORS AND STUDENTS WITH OPPOSITION VIEWS.

D. FAMILY: THE ASSOCIATION OF FAMILY MEMBERS OF DISAPPEARED PERSONS WILL ATTEND AS A GROUP A SPECIAL MASS TO BE CELEBRATED AT THE CATHEDRAL WITH THE CARDINAL OFFICIATING TO WHICH THE WORKING GROUP WILL BE INVITED. THE MASS IS SCHEDULED TO TAKE PLACE DURING THE WEEK OF 17 JULY. AS AN ADJUNCT TO THE DISAPPEREDS PROBLEM THE LEFTIST THEATER GROUP (IMAGEN\* HAS PRODUCED A PLAY WHICH DEALS WITH THE DISAPPEARED IN DRAMATIC FASHION.

3. PCCH PLANS FOR DIRECT ACTION IN SUPPORT OF THE DISSAPEARED WHICH HAD BEEN SET IN MOTION FOLLOWING THE CONCLUSION OF THE HUNGER STRIKE IN JUNE WRE PUT IN ABEYANCE LARGELY AS A RESULT OF THE

PARTY'S ANALYSIS OF THE RELATIVE WEAKNESS OF PRESIDENT AUGUSTO PINOCHET DURING THE CRISIS PERIOD WITH THE U.S. OVER THE ORLANDO LETELLIER CASE. THE PARTY DID NOT WANT TO STIMULATE ANY ACTION DURING THIS DELICATE PERIOD WHICH WOULD GIVE PINOCHET AN EXCUSE TO DIVERT ATTENTION FROM HIS BASIC PROBLEMS.

COMMENT:

THE PCCM HAD PLANNED TO ATTEMPT TO STIMULATE DIRECT ACTIONS, SUCH AS DEMONSTRATIONS, MARCHES AND TAKEOVERS OF UNIVERSITY FACILITIES IN ORDER TO DRAMATIZE DISSATISFACTION WITH THE GOVERNMENT'S HANDLING OF THE PROBLEM OF MISSING PERSONS).

4. (EMBASSY) COMMENT: SEE SANTIAGO 5102 FOR A SIMILAR HOPEFUL STATEMENT ON THE POSSIBILITIES OF AVOIDING MAJOR CONFRONTATIONS DURING THE VISIT OF THE AD HOC WORKING GROUP. GIVEN THE INTENSE HUMAN FEELINGS INVOLVED, AND THE VARIETY OF POLITICAL AND OTHER INTERESTS AT STAKE, THE CHURCH AND THE COMMUNIST PARTY WILL BE DOING WELL IF THEY CAN KEEP CRITICS AND OPPONENTS OF THE REGIME UNDER CONTROL).
